2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 ACCEPTING A DONATION OF TWO JAMES TANDI
5 SCULPTURES, "LADY NITA" AND "NDEBELE CHIEF,"
6 FROM MR. ROSS PARKER, VALUED AT MORE THAN FIVE
7 HUNDRED DOLLARS (\$500), FOR THE USE AND BENEFIT
8 OF THE AFRICAN-AMERICAN RESEARCH LIBRARY AND
9 CULTURAL CENTER; AUTHORIZING THE COUNTY
10 ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND
11 BUDGETARY ACTIONS TO IMPLEMENT ACCEPTANCE;
12 AND PROVIDING FOR SEVERABILITY AND AN
13 EFFECTIVE DATE.

14 WHEREAS, Mr. Ross Parker has most generously offered to donate to the County
15 two James Tandi sculptures, "Lady Nita" and "Ndebele Chief," valued at more than Five
16 Hundred Dollars (\$500), for the use and benefit of the African-American Research Library
17 and Cultural Center; and

18 WHEREAS, Section 18.63 of the Broward County Administrative Code provides
19 for the acceptance and acknowledgement by the Board of County Commissioners of
20 Broward County, Florida ("Board"), of donations to the County that are valued at Five
21 Hundred Dollars (\$500) or more; and

22 WHEREAS, the Board wishes to accept the generous gift, and to express its
23 gratitude for such donation, NOW, THEREFORE,

24 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
BROWARD COUNTY, FLORIDA:

1 Section 1. The Board hereby accepts the donation of two James Tandi
2 sculptures, "Lady Nita" and "Ndebele Chief," valued at more than Five Hundred Dollars
3 (\$500), from Mr. Ross Parker, whose address is 18159 South East Ridgeview Drive,
4 Tequesta, Florida 33469, for the use and benefit of the African-American Research
5 Library and Cultural Center.

6 Section 2. The County Administrator is hereby authorized to take all
7 administrative and budgetary actions and execute all forms required to implement
8 acceptance of the donation.

9 Section 3. SEVERABILITY.

10 If any portion of this Resolution is determined by any Court to be invalid, the invalid
11 portion shall be stricken, and such striking shall not affect the validity of the remainder of
12 this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot
13 be legally applied to any individual(s), group(s), entity(ies), property(ies), or
14 circumstance(s), such determination shall not affect the applicability hereof to any other
15 individual, group, entity, property, or circumstance.

16 Section 4. EFFECTIVE DATE.

17 This Resolution shall become effective upon adoption.
