## Third Amendment to Agreement between Broward County and Chi-Ada Corporation for Janitorial Services for South Regional Courthouse (RFP# R0921804P1)

This is a Third Amendment to the December 13, 2011 Agreement for Janitorial Services for South Regional Courthouse ("Third Amendment") entered into by and between Broward County, a political subdivision of the State of Florida (the "County") and Chi-Ada Corporation, a Florida corporation ("Second Party") (collectively, the "Parties").

WHEREAS, the Parties entered into an agreement effective December 13, 2011, wherein, Second Party provided the County with janitorial services for the Broward County South Regional Courthouse (the "Agreement"); and

WHEREAS, the Agreement was amended on December 6, 2016, to extend its term until June 13, 2017, (the "First Amendment"); and

WHEREAS, the Agreement was amended again on May 23, 2017, to extend its term until December 14, 2017, (the "Second Amendment"); and

WHEREAS, the Parties wish to again extend the term of the Agreement on a month-to-month basis, for a period not to exceed six months or until a replacement contract is awarded, whichever comes first; NOW, THEREFORE,

IN CONSIDERATION of the mutual terms, conditions, promises, and covenants hereinafter set forth, the Parties agree as follows:

- The Agreement shall be extended on a month-to-month basis for a period not to exceed six months or until a replacement contract is awarded, whichever comes first.
- This Third Amendment shall take effect on December 15, 2017, and may be fully executed in multiple copies by all parties, each of which, bearing original signatures, shall have the force and effect of an original document.
- Except to the extent modified herein, the Agreement shall remain in full force and
  effect. In the event of a conflict between the terms and conditions of this Third
  Amendment and the terms and conditions set forth in the Agreement, this
  document controls.
