## Second Amendment to Agreement between Broward County and Triangle Services of Florida, Inc. for Janitorial Services for the Broward County Judicial Complex (RFP# R0899203P1)

This is a Second Amendment to the March 21, 2014 Agreement for Janitorial Services for Broward County Judicial Complex ("Second Amendment") entered into by and between Broward County, a political subdivision of the State of Florida (the "County") and Triangle Services of Florida, Inc., a Florida corporation ("Second Party") (collectively, the "Parties").

WHEREAS, the Parties entered into an emergency agreement effective February 17, 2014, wherein, Second Party provided the County with janitorial services for the Broward County Judicial Complex (the "Agreement"); and

WHEREAS, the Agreement was amended on June 13, 2017, to change the prices, terms, and conditions due to occupancy change and extend its term until December 26, 2017, (the "First Amendment"); and

WHEREAS, the Parties wish to again extend the term of the Agreement on a month-to-month basis, for a period not to exceed six months or until a replacement contract is awarded, whichever comes first; NOW, THEREFORE,

IN CONSIDERATION of the mutual terms, conditions, promises, and covenants hereinafter set forth, the Parties agree as follows:

- The Agreement shall be extended on a month-to-month basis for a period not to exceed six months or until a replacement contract is awarded, whichever comes first.
- 2. This Second Amendment shall take effect on December 27, 2017, and may be fully executed in multiple copies by all parties, each of which, bearing original signatures, shall have the force and effect of an original document.
- Except to the extent modified herein, the Agreement shall remain in full force and
  effect. In the event of a conflict between the terms and conditions of this Third
  Amendment and the terms and conditions set forth in the Agreement, this
  document controls.
