

Second Amendment to Agreement between Broward County and Chi-Ada Corporation for Janitorial Services for Main Library (RFP# R0899203P1)

This is a Second Amendment to the June 5, 2012 Agreement for Janitorial Services for Broward County's Main Library ("Second Amendment") entered into by and between Broward County, a political subdivision of the State of Florida (the "County") and Chi-Ada Corporation, a Florida corporation ("Second Party") (collectively, the "Parties").

WHEREAS, the Parties entered into an agreement effective June 5, 2012, wherein, Second Party provided the County with janitorial services for Broward County's Main Library (the "Agreement"); and

WHEREAS, the Agreement was amended on May 23, 2017, to extend its term until December 4, 2017, (the "First Amendment"); and

WHEREAS, the Parties wish to again extend the term of the Agreement on a month-to-month basis, for a period not to exceed six months or until a replacement contract is awarded, whichever comes first; NOW, THEREFORE,

IN CONSIDERATION of the mutual terms, conditions, promises, and covenants hereinafter set forth, the Parties agree as follows:

1. The Agreement shall be extended on a month-to-month basis for a period not to exceed six months or until a replacement contract is awarded.
2. This Second Amendment shall take effect on December 5, 2017, and may be fully executed in multiple copies by all parties, each of which, bearing original signatures, shall have the force and effect of an original document.
3. Except to the extent modified herein, the Agreement shall remain in full force and effect. In the event of a conflict between the terms and conditions of this Second Amendment and the terms and conditions set forth in the Agreement, this document controls.


