2 AN ORDINANCE OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 PERTAINING TO CHILD CARE FACILITIES AND FAMILY
5 CHILD CARE HOMES; AMENDING VARIOUS SECTIONS
6 OF CHAPTERS 7 AND 20 OF THE BROWARD COUNTY
7 CODE OF ORDINANCES ("CODE") RELATING TO
8 MINIMUM STANDARDS FOR CHILD CARE FACILITIES
9 AND FAMILY CHILD CARE HOMES; REQUIRING ALL
10 CHILD CARE PERSONNEL AND FAMILY CHILD CARE
11 HOME PERSONNEL WHO PROVIDE CARE TO INFANTS
12 TO OBTAIN TRAINING ON PROVIDING AN INFANT SAFE
13 SLEEP ENVIRONMENT; REQUIRING CHILD CARE
14 FACILITIES AND FAMILY CHILD CARE HOMES TO
15 IMPLEMENT, MAINTAIN, AND COMPLY WITH WRITTEN
16 POLICIES PROVIDING FOR AN INFANT SAFE SLEEP
17 ENVIRONMENT; UPDATING MINIMUM STANDARDS
18 RELATING TO STAFF-TO-CHILDREN RATIOS FOR
19 CHILDREN NAPPING AND SLEEPING IN CHILD CARE
20 FACILITIES; AND PROVIDING FOR SEVERABILITY,
21 INCLUSION IN THE CODE, AND AN EFFECTIVE DATE.

23 WHEREAS, child care licensing is regulated under Section 402.301, et seq.,
24 Florida Statutes; and

WHEREAS, pursuant to its authority under Chapter 402, Florida Statutes, and
Rules 65C-20 and 65C-22, Florida Administrative Code ("FAC"), the Broward County
Board of County Commissioners ("Board") previously enacted the "Broward County Child
Care Ordinance," and the "Family Child Care Home Ordinance," codified in
Chapter 7 and Chapter 20, Article XV, respectively, of the Broward County Code of
Ordinances ("Code"), to administer, enforce, and regulate the operation of child care
facilities and family child care homes in Broward County through a licensure or
registration process; and

1 WHEREAS, the State of Florida, Department of Children and Families ("DCF")
2 adopted changes to Rules 65C-20 and 65C-22, FAC, effective October 25, 2017, relating
3 to minimum standards for family child care homes and child care facilities, respectively,
4 which impact various provisions under the Broward County Child Care Ordinance and the
5 Family Child Care Home Ordinance, in that certain minimum standards are no longer
6 specifically addressed in the above-referenced FAC rules and, instead, such standards
7 are set forth respectively in the DCF Child Care Facility Handbook and the DCF Family
8 Day Care Home/Large Family Child Care Home Handbook, which are incorporated by
9 reference into such FAC rules; and

10 WHEREAS, the Board desires to amend various sections of the Code to establish
11 additional minimum standards for child care facilities and family child care homes relating
12 to napping and sleeping of children; to require child care providers to implement, maintain,
13 and comply with written policies providing for an infant safe sleep environment consistent
14 with the requirements under this Ordinance; to require child care personnel and family
15 child care home personnel who provide care to infants to obtain the most current training,
16 approved by the local licensing agency on providing an infant safe sleep environment;
17 and to provide documentation evidencing the successful completion of such training as
18 provided herein; and

19 WHEREAS, the Board finds that amending the Code as provided herein will
20 establish an infant safe sleep environment and require all owners and operators of
21 licensed and registered child care facilities and family child care homes to develop a
22 written safe sleep policy to reduce the risk of sudden unexpected infant death (SUID),
23 which includes, but is not limited to, sudden infant death syndrome (SIDS), suffocation,
24 entrapment, or strangulation,

1 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
2 BROWARD COUNTY, FLORIDA:

4 Section 1. Section 7-4.02 of the Broward County Code of Ordinances is hereby
5 amended to read as follows:

6 **Sec. 7-4.02. Personnel training.**

7 ...

8 (j) All child care personnel who provide care to infants at child care facilities
9 shall, prior to caring for such infants, successfully complete the most current
10 training course(s) approved by the local licensing agency relating to providing an infant
11 safe sleep environment, as identified on the local licensing agency's website. The owner
12 of a child care facility must ensure that all such child care personnel are in compliance
13 with the training requirements of this section, and that such training is renewed every two
14 (2) years, in the same manner as provided for the initial training. Successful completion
15 of the required training must be evidenced by a certificate, or any equivalent
16 documentation, issued by the applicable training organization in the name of the individual
17 who completed the course and indicating the date the course was completed.
18 Documentation evidencing compliance with the training requirements under this section
19 shall be included in the individual's personnel file maintained at the child care facility.

20
21 Section 2. The title of Section 7-4.06 and the text of Section 7-4.06(a) of the
22 Broward County Code of Ordinances are hereby deleted in their entirety and a new title
23 of Section 7-4.06 and text of Section 7-4.06(a) are created to read as follows:

1 **Sec. 7-4.06. Ratios of staff-to-children and supervision.**

2 (a) *General.*

3 (1) This section establishes the minimum standards for staff-to-children ratios
4 and supervision in child care facilities. The owner of a child care facility
5 must ensure compliance with the minimum standards set forth in
6 Section 402.305(4), Florida Statutes, and Section 2 of the State of Florida,
7 Department of Children and Families' Child Care Facility Handbook ("DCF
8 Facility Licensing Handbook"), incorporated by reference into
9 Rule 65C-22.001, Florida Administrative Code, relating to staff-to-children
10 ratios and supervision, in addition to the more stringent requirements set
11 forth in this section.

12 (2) *Napping and sleeping.* When children are napping and sleeping,
13 supervision must be maintained in accordance with the staff-to-children
14 ratios set forth below.

<i>Napping and Sleeping Children</i>	<i>Staff-to-Children Ratio</i>
Under 1 year of age	No more than 4 children in this age range for each staff member
1 year of age but under 2 years of age	No more than 6 children in this age range for each staff member

2 years of age but under 3 years of age	No more than 22 children in this age range for each staff member
3 years of age and older	No more than 30 children in this age range for each staff member

- a. In groups of mixed age ranges, where children under one year of age are included, one staff member must be responsible for no more than four children of any age group.
 - b. In groups of mixed age ranges, where there are no children under one year of age, and children one year of age but under two years of age are included, one staff member must be responsible for no more than six children of any age group.
 - c. In groups of mixed age ranges, where no child is younger than two years of age, the staff-to-children ratio shall be based on the age group with the largest number of children within the group.
- (3) All child care personnel must remain awake at all times when children are in care.

Section 3. Section 7-5.04 of the Broward County Code of Ordinances is hereby deleted in its entirety and a new Section 7-5.04 is created to read as follows:

1 **Sec. 7-5.04. Napping and sleeping space; safe sleep environment.**

2 (a) This section establishes the minimum standards for napping and sleeping
3 space, and for providing a safe sleep environment in child care facilities. The owner of a
4 child care facility must ensure compliance with the minimum standards set forth in
5 Sections 2.4 and 3.6 of the State of Florida, Department of Children and Families' Child
6 Care Facility Handbook ("DCF Facility Licensing Handbook"), incorporated by reference
7 into Rule 65C-22.001, Florida Administrative Code, relating to supervision, and
8 napping and sleeping requirements, respectively, in addition to the more stringent
9 requirements set forth in this section.

10 (b) All owners of child care facilities shall obtain approval from the local
11 licensing agency prior to caring for infants.

12 (c) All cribs and play yards utilized in child care facilities for napping and
13 sleeping must be in compliance with the crib requirements set forth in Section 3.6.3 of the
14 DCF Facility Licensing Handbook, in addition to the more stringent requirements set forth
15 below.

16 (1) All cribs and play yards shall contain mattresses or mats that fit the
17 dimensions of such cribs or play yards without any gaps and that are in
18 compliance with the manufacturer's specifications for mattresses or mats to
19 be utilized in such cribs and play yards;

20 (2) All crib and play yard mattresses must be covered with a tightly-fitted sheet
21 and be capable of maintaining their shape when covered with such fitted
22 sheet; and

1 (3) Cribs and play yards shall not be positioned near any potential safety
2 hazard including, but not limited to, any window blinds, draperies, or
3 electrical cords.

4 (d) *Infant safe sleep environment.* This section establishes the minimum
5 standards for providing an infant safe sleep environment in child care facilities and shall
6 be in addition to the safe sleep requirements set forth in Section 3.6.4 of the
7 DCF Facility Licensing Handbook.

8 (1) Unless authorized in writing by a physician, infants who are napping or
9 sleeping must be positioned on their backs and on a firm surface to reduce
10 the risk of sudden unexpected infant death (SUID), including sudden infant
11 death syndrome (SIDS), and without the use of any devices or equipment,
12 including, but not limited to, infant wedges or sleep positioners. Any
13 physician authorization pursuant to this section shall include the child's
14 name, date of birth, a description of the alternate napping or sleeping
15 position, any approved devices or equipment, and the length of time such
16 authorization is valid. Such authorization shall be maintained in the infant's
17 enrollment file at the child care facility. The owner of a child care facility
18 shall ensure that all substitute providers of care at the facility are informed
19 of any written authorization provided by a physician pursuant to this section.
20 Except where authorized in accordance with the provisions of this section,
21 all infants who are observed sleeping on their stomachs shall be
22 repositioned onto their backs.

23 (2) At all times when infants are napping or sleeping, mobiles hanging above
24 cribs or play yards shall be prohibited, and no items shall be contained

1 inside, attached to, or hung on any crib or play yard, including, but not
2 limited to, pillows, toys, stuffed animals, bumper pads, bibs, blankets, quilts,
3 or comforters. Infants may use pacifiers while napping or sleeping, as long
4 as such pacifiers are not tied or fastened to the infants' clothing or to the
5 crib or play yard.

6 (3) Swaddling of infants is prohibited at all times, unless authorized in writing
7 by a physician and such documentation is provided and maintained in a
8 manner consistent with the requirements of (d)(1) above. The owner of a
9 child care facility shall ensure that all substitute providers of care at the
10 facility are informed of any written authorization provided by a physician
11 pursuant to this section. Infants may be placed in one-piece sleepers or
12 sleep sacks that are not capable of being kicked off by the children. Infants
13 shall not be placed for napping or sleeping wearing any bibs, necklaces, or
14 garments with tie strings or hoods. Infants shall be observed to ensure they
15 are comfortably clothed in accordance with the room temperature and
16 demonstrate no visible signs of being cold, overheated, or sweating.

17 (4) Infants shall not be placed for napping or sleeping in any car safety seat,
18 bean bag chair, bouncy seat, infant seat, swing, jumping chair, highchair,
19 chair, futon, sofa, or any other type of furniture or equipment that does not
20 meet the crib and play yard requirements under (c) above.

21 (5) Infants who arrive at the facility asleep in a car safety seat must be
22 immediately removed from the seat by the parent or the child care personnel
23 and placed on their back in a safe sleep environment.
24

2 or sleeping.

3 (e) All owners of child care facilities shall implement, maintain, and comply with
4 a written policy on providing an infant safe sleep environment, which policy, at minimum,
5 shall include the requirements under this section.

6 (f) The owner of a child care facility shall ensure that all parents of infants are
7 provided a copy of the child care facility's written policy on providing an infant safe sleep
8 environment upon enrollment of their child(ren). A copy of the signed statement from the
9 parent acknowledging receipt of the policy must be included in the child's enrollment file
10 maintained at the child care facility.

11
12 Section 4. Section 7-22.04 of the Broward County Code of Ordinances is
13 hereby amended to read as follows:

14 **Sec. 7-22.04. Napping and sleeping space; safe sleep environment.**

15 For the purposes of this section, the ~~general requirements~~ minimum standards set
16 forth in Article I, Section 7-5.04, relating to napping and sleeping space set forth in
17 Sec. 7-5.04 of this Ordinance and for providing a safe sleep environment, shall be
18 applicable to ~~Article II.~~

19
20 Section 5. Section 7-38.06 of the Broward County Code of Ordinances is
21 hereby amended to read as follows:

22 **Sec. 7-38.06. Napping and sleeping space; safe sleep environment.**

23 For the purposes of this section, the ~~general requirements~~ minimum standards set
24 forth in Article I, Section 7-5.04, relating to napping and sleeping space set forth in Sec.

9 (b) Linens, if provided by the facility, must be sanitized daily, ~~pursuant to in~~
10 accordance with Sec. Section 7-3(34) of this Ordinance, and more often if soiled or dirty.
11 ~~Linens and blankets must be provided when children are napping or sleeping. Pillows~~
12 ~~must be available except for infants under twenty four (24) months of age.~~

13 (c) ~~For the purpose of this section, sleeping refers to the normal overnight sleep~~
14 ~~cycle while napping refers to a brief period of rest during daylight or early evening hours.~~
15 ~~Playpens may not be used for care when children are sleeping. Bedding must be~~
16 ~~appropriate for the child's size.~~

17
18 Section 7. Section 7-46 of the Broward County Code of Ordinances is hereby
19 amended to read as follows:

20 **Sec. 7-46. Adoption of Florida Statutes and Florida Administrative Code.**

21 F.S. ch. Chapter 402, Florida Statutes, Rule 65C-22, Florida Administrative Code,
22 including any standards set forth in the current version of any State of Florida, Department
23 of Children and Families' Child Care Facility Handbook and School-Age Child Care
24 Licensing Handbook incorporated by reference into Rule 65C-22, Florida Administrative

16 family child care home shall, prior to caring for such infants, successfully complete the
17 most current training course approved by the local licensing agency relating to providing
18 an infant safe sleep environment, as identified on the local licensing agency's website.
19 The operator of a family child care home must ensure that all such family child care home
20 personnel are in compliance with the training requirements of this section, and that such
21 training is renewed every two (2) years, in the same manner as provided for the initial
22 training. Successful completion of the required training must be evidenced by a
23 certificate, or any equivalent documentation, issued by the applicable training
24 organization in the name of the individual who completed the course and indicating the

9 V. *Napping and Sleeping Space; Safe Sleep Environment.*

10 (a) This section establishes the minimum standards for napping and sleeping
11 space and for providing a safe sleep environment in family child care
12 homes. The operator of a family child care home must ensure compliance
13 with the minimum standards set forth in Sections 6 and 7.8 of the State of
14 Florida, Department of Children and Families' Family Day Care Home/Large
15 Family Child Care Home Handbook ("DCF Family Child Care Home
16 Licensing Handbook"), incorporated by reference into Rule 65C-20.008,
17 Florida Administrative Code, relating to supervision and appropriate, safe
18 and sanitary bedding, respectively, in addition to the more stringent
19 requirements set forth in this section.

20 (b) All operators of family child care homes shall obtain approval of the local
21 licensing agency prior to caring for infants.

22 (c) All cribs and play yards utilized in family child care homes for napping and
23 sleeping must be in compliance with the crib requirements set forth in
24

- 13 (d) In addition to the requirements of Section 6 of the DCF Family Child Care
14 Home Licensing Handbook relating to supervision of children, children from
15 birth to twenty-four (24) months of age who are napping or sleeping shall
16 be observed by sight and sound. Use of electronic audio and video
17 monitoring equipment is permissible, except in large family child care
18 homes, as defined in Section 402.302(11), Florida Statutes, where direct
19 supervision of such children is required at all times.
- 20 (e) *Infant safe sleep environment.* This section establishes the minimum
21 standards for providing an infant safe sleep environment in family child care
22 homes. All operators of family child care homes shall ensure compliance
23 with the requirements under this section, in addition to any other minimum

7 Section 10. Section 20-309 of the Broward County Code of Ordinances is hereby
8 amended to read as follows:

9 **Sec. 20-309. Adoption of Florida Statutes and Florida Administrative Code.**

10 Chapter 402, Florida Statutes, Rule 65C-20, Florida Administrative Code, including
11 any standards set forth in the current version of any State of Florida, Department of
12 Children and Families' Family Day Care Home/Large Family Child Care Home Handbook,
13 incorporated by reference into Rule 65C-20, Florida Administrative Code, and any other
14 applicable federal, state, or local law, rule, or regulation, or standard relating to the
15 minimum standards for licensure of family child care homes are hereby adopted and
16 incorporated into this Ordinance by reference. In the ~~case of a direct conflict between~~
17 ~~any provision of~~ event the minimum standards for licensure of family child care homes
18 under this Ordinance and a provision differ from the minimum standards of any other
19 applicable federal, state, or local law, rule, or regulation, or standard, the more ~~restrictive~~
20 stringent provision shall apply.

21
22 Section 11. SEVERABILITY.

23 If any portion of this Ordinance is determined by any Court to be invalid, the invalid
24 portion shall be stricken, and such striking shall not affect the validity of the remainder of

6 Section 12. INCLUSION IN CODE.

7 It is the intention of the Board of County Commissioners that the provisions of this
8 Ordinance shall become and be made a part of the Broward County Code; and that the
9 sections of this Ordinance may be renumbered or relettered and the word "ordinance"
10 may be changed to "section," "article," or such other appropriate word or phrase in order
11 to accomplish such intentions.

12

13 Section 13. EFFECTIVE DATE.

14 This Ordinance shall become effective on April 1, 2018.
