Medical Marijuana Dispensaries in BMSD

During discussion at first reading of the Ordinance, on January 9, 2017, the Board raised several questions. Please find the questions below with staff responses.

# 1. What options does the Board have to regulate Medical Marijuana?

The Board has zoning authority within the unincorporated Broward Municipal Service District (BMSD). Subsection 381.986(11)(b)1, Florida Statutes, provides that the Board may either ban Medical Marijuana dispensaries in the BMSD, or regulate them in the same manner as pharmacies are regulated.

#### 2. Is there a statutory deadline for adoption of this Ordinance?

The Statute has no deadline for the Board to make a determination. However, the County Attorney has advised that currently, under the Statute, Medical Marijuana dispensaries are regulated as pharmacies. Therefore, unless the Board takes action to ban them, Medical Marijuana Dispensaries will continue to be permitted in BMSD in zoning districts where pharmacies are permitted, but without the additional parking requirements that are proposed in the Ordinance.

# 3. Which BMSD locations would allow Medical Marijuana dispensaries?

Please see attached Exhibits 1, 2 and 3 which were previously distributed to the Board on September 26, 2017 (Agenda item 34.)

# 4. What action have municipalities in Broward County taken?

Currently, 14 municipalities have chosen to ban Medical Marijuana Dispensaries and eight (8) have approved regulations to permit them. In addition, nine (9) have a temporary moratorium in place. Please see attached updated Exhibit 4.

#### 5. Could the Board enact an Moratorium?

The Board could approve a temporary moratorium for six (6) months. However, that would require starting a new public hearing process. During the interim time period Medical Marijuana Dispensaries will continue to be permitted in BMSD in zoning districts where pharmacies are permitted, but without the additional parking requirements that are proposed in the Ordinance.

# 6. What is the status of the Medical Marijuana Advisory Board?

Per Article XVI Section 1-310 of the Code of Ordinances, the Advisory Board has twelve members, of which six have been appointed (as of 1/9/2018). The Board requires 7 members present for a quorum to conduct businesses.

# 7. Could the Medical Marijuana Advisory Board (MMAB) review the Ordinance?

Per Article XVI Section 1-312(c) of the Code of Ordinances, the Advisory Board's duties and functions include: "Providing recommendations to the Board regarding regulations and fees related to medical marijuana treatment centers." However, the MMAB does not yet have sufficient members to form a quorum, and therefore has not yet held a meeting.

# 8. How were BMSD communities notified of the proposed Ordinance?

In addition to the public notices legally required for this ordinance, staff has reached out the Central County Advisory Board (which has members from Boulevard Gardens, Franklin Park, Roosevelt Gardens and Washington Park) and Broadview Park Civic Association on multiple occasions in person and by email. North County area of BMSD does not have a formal association. However, staff presented an update to North County BMSD residents at a recent workshop. Please see attached Exhibit 5 for additional information.

#### 9. Are there any dispensaries in BMSD?

There is one licensed physician operating a medical office under the name "Marijuana Doctor", located at 1413 South State Rd 7 in Broadview Park neighborhood. This business is a medical office, not a dispensary. Staff have received inquiries from Medical Marijuana businesses concerning properties in Central County area of BMSD.

#### 10. Are there any dispensaries in Broward County?

Currently, the Florida Department of Health's database lists 25 Licensed medical marijuana treatment centers are authorized to cultivate, process and dispense medical marijuana. None are in Broward County (two are located in Miami-Dade County).

#### 11. Is Medical Marijuana a cash-only business?

Because Marijuana remains illegal under Federal Law, banks that regulated under federal law will not provide services to Medical Marijuana businesses. However, some community banks and/or credit unions may do so. First Green Bank, a Central Florida community bank, had provided

services in Florida, however it was recently reported to be "closing marijuana business accounts ahead of an acquisition by a larger financial institution" (Miami Herald 12/22/2017). In addition, Medical Marijuana is not covered by health insurance plans or Medicaid.

# 12. In what forms can Medical Marijuana be dispensed to patients?

As of this writing, State Law provides that Low THC Cannabis and Medical Marijuana can only be dispensed in medical forms (smokable marijuana leaves are not permitted.)

#### 13. Did Broward County BMSD voters support Medical Marijuana?

A Constitutional Amendment was approved by in November 2016. Broward County residents voted approved 75.61% in Favor. Within the BMSD, the Supervisor of Election reports:

Central County precincts voted 74.44% in Favor; Broadview Park precincts voted 71.03% in Favor; and North County BMSD voted 76.66% in Favor.


# 14. Would revenues from future business development remain in the BMSD?

Revenues from Property taxes and Business Tax Receipts (formerly known as Occupational License fees) would be designated for the BMSD. Medical Marijuana purchases are exempt from Sales Tax.



500 feet from Schools







