Solid Waste Disposal Support Services - February 6, 2018 Agenda Item #45

Attached, are three charts providing additional information related to the solid waste program for Broward County.

#### Chart 1

Identifies the municipal solid waste providers for all 31 cities and the unincorporated area. The Chart also identifies the amount of solid waste sent to Wheelabrator for cities under the County's Inter-local Agreement (ILA) with Wheelabrator for **2017**, **totaling 746,278**. The County does not have current information for cities using other providers, with the exception of Sunrise; which also uses Wheelabrator. For non Wheelabrator ILA cities, information related to tonnage reflects **2012** data, the last year of the Resource Recovery Board, totaling **626,145**. The total estimated tonnage for Broward County is **1,372,423**.

#### Chart 2

Identifies the unincorporated area and cities that currently participate under the County's ILA with Wheelabrator and Joint Venture Sun-Bergeron for municipal solid waste disposal, yard waste, bulk and C&D for the contract period ending July 2018. There are a total of 16 entities, inclusive of the unincorporated area that fall under the ILAs.

#### Chart 3

Noting that the joint venture Sun-Bergeron is not being recommended for renewal, this chart identifies those cities that have indicated a willingness to use the County's ILA with Wheelabrator for the new contract period ending in 2023.

It is important to note that the capacity at the South waste-to-energy plant is 821,250 tons with the capacity of an additional 273,250 tons for a total of 1,094,500. Notwithstanding the fact that Wheelabrator's South Plant accepts waste from entities other than Broward County, our agreement calls for all of Broward's processable waste to be incinerated.
