FLORIDA. **AUTHORIZING APPROPRIATION** ΑN DISBURSEMENT OF RYAN WHITE PART A FUNDS TO SERVICE PROVIDERS FOR FISCAL YEAR 2018 IN THE ESTIMATED AMOUNT OF \$13,959,503; EXTENDING THE OF **CERTAIN** PREVIOUSLY **APPROVED** TERM AGREEMENTS FOR SIX MONTHS; AUTHORIZING THE COUNTY ADMINISTRATOR **EXECUTE** TO AND EXTENSION AMENDMENTS TO TAKE **BUDGETARY** NECESSARY ADMINISTRATIVE AND ACTIONS TO IMPLEMENT THE AGREEMENTS: AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the United States Department of Health and Human Services, Health Resources and Services Administration ("HRSA") annually awards Broward County funds for the provision of Ryan White Part A core medical and support services, Minority AIDS Initiative ("MAI") services, and planning and evaluation services within Broward County, Florida, collectively referred to as "Services"; and

WHEREAS, the Board of County Commissioners of Broward County, Florida ("Board"), approved an application for Ryan White Part A and MAI Fiscal Year 2018 grant funding on October 17, 2017, and expects to be awarded the grant and receive payment of the funds from HRSA on or about March 1, 2018; and

WHEREAS, the Board desires to appropriate and disburse funding for the provision of Services to the specified service providers for Fiscal Year 2018; and

WHEREAS, the Board also desires to amend the term of the agreements with the service providers listed in Attachment B, and to authorize the Broward County Administrator ("County Administrator") to execute the individual extension amendment with those service providers on behalf of the Board; and

WHEREAS, the Board finds that the Services to be funded benefit the residents of Broward County and serve a public purpose, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

## Section 1. <u>Authorized Appropriations and Disbursements</u>.

The Board hereby authorizes appropriation and disbursement of funds for Fiscal Year 2018 as set forth in Attachments A and B hereto.

### Section 2. <u>Execution of Amendments by the County Administrator</u>.

The County Administrator is hereby authorized to execute amendments to extend the term of the agreements with the service providers listed in Attachment B for a period not to exceed six (6) months, and to take all necessary administrative and budgetary actions to implement the agreements and amendments commencing March 1, 2018. Nothing in this Resolution shall be construed to alter the requirement that the amendments to the agreements be approved by the Office of the County Attorney prior to execution. Any material deviations from the approved agreements shall be presented to the Board for approval.

#### Section 3. SEVERABILITY.

If any portion of this Resolution is determined by any Court to be invalid, the invalid portion shall be stricken, and such striking shall not affect the validity of the remainder of this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies),
