Reporting Obligations:	The Organization agrees to provide the following report to PetSmart Charities, in connection with the Statement of Terms, on or before the deadlines set forth below. PetSmart Charities reserves the right to change the method and format of how report are provided. Final report due 120 days after execution of this Grant Statement via https://www.cybergrants.com/petsmartcharities/reports/app -provide a description of how the supplies were used -provide any photos and stories of the people and pets who were helped with grant funds
Additional Terms:	PetSmart Charities supports established best practices for transport such as those guidelines included in the Association of Shelter Veterinarians Guidelines for Standards of Care in Animal Shelters. Organization must operate transport vehicles within the Association of Shelter Veterinarians recommended transport guidelines.
