Grant Purpose:	In-kind supplies totaling \$90,297.65 comprised of various non-consumables supplies utilized during Emergency Relief efforts. Any press materials created by the Organization shall be submitted to PetSmart Charities to PublicRelations@petsmartcharities.org for review, prior to use, including any and all promotional or advertising materials, press releases, written communication and/or social media posts in which PetSmart Charities' name, trademarked material or copyrighted material is used, at least 10 business days in advance of advertising and print deadlines.
