ORDINANCE NO. 2018-

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, PERTAINING TO ELEVATORS; AMENDING SECTION 8½-16(aa) OF THE BROWARD COUNTY CODE OF ORDINANCES ("CODE") TO CORRECT A SCRIVENER'S ERROR AND CLARIFY LANGUAGE REGARDING PENALTIES FOR VIOLATIONS OF PROVISIONS RELATED TO DOCUMENTATION OF ELEVATOR SERVICE; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE CODE, AND AN EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Section 8½-16(aa) of the Broward County Code of Ordinances is hereby amended to read as follows:

(aa) *Violations of Section 21-8, Relating to Documentation of Elevator Service:*

(2)	Falsely reporting to County <u>Division</u> that building owner refused to sign the Record of Visit (sec. 29-8 <u>21-8</u> (c)(3))	500.00	500.00

1 Section 2. SEVERABILITY.

2 If any portion of this Ordinance is determined by any Court to be invalid, the invalid
3 portion shall be stricken, and such striking shall not affect the validity of the remainder of
4 this Ordinance. If any Court determines that this Ordinance, or any portion hereof, cannot
5 be legally applied to any individual(s), group(s), entity(ies), property(ies), or
6 circumstance(s), such determination shall not affect the applicability hereof to any other
7 individual, group, entity, property, or circumstance.

8 Section 3. INCLUSION IN CODE.

9 It is the intention of the Board of County Commissioners that the provisions of this
10 Ordinance shall become and be made a part of the Broward County Code; and that the
11 sections of this Ordinance may be renumbered or relettered and the word
12 "ordinance" may be changed to "section," "article," or such other appropriate word or phrase
13 in order to accomplish such intentions.

14 Section 4. EFFECTIVE DATE.

15 This Ordinance shall become effective as provided by law.
