RESOLUTION NO. 2018-

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY. FLORIDA. APPROVING AN AMENDMENT TO THE JOINT LOCAL HOUSING ASSISTANCE PLAN ("LHAP") FOR THE STATE OF FLORIDA'S FISCAL YEARS 2018 AND 2019, UNDER THE STATE HOUSING INITIATIVES PARTNERSHIP ACT, THROUGH SECTIONS 420.907 420.9079, **FLORIDA** STATUTES AND RULE 67-37 **FLORIDA ADMINISTRATIVE** CODE; AUTHORIZING DIRECTING THE COUNTY ADMINISTRATOR TO AMEND THE LHAP TO ADD A NEW STRATEGY, COMMUNITY **EXECUTE** LAND TO ANY TRUST. NECESSARY DOCUMENTS RELATING TO THE AMENDED LHAP, AND TO SUBMIT THE AMENDED LHAP TO THE FLORIDA HOUSING FINANCE CORPORATION FOR REVIEW AND APPROVAL; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the State of Florida enacted the William E. Sadowski Affordable Housing Act, Chapter 92-317, Laws of Florida, allocating a portion of documentary stamp taxes on deeds to local governments for the development and maintenance of affordable housing; and

WHEREAS, the State Housing Initiatives Partnership ("SHIP") Act, codified in Sections 420.907 through 420.9079, Florida Statutes, and Rule 67-37, Florida Administrative Code, collectively referred to as the "SHIP Rules and Regulations," require local governments seeking a distribution of SHIP funding to develop a one- to three-year Local Housing Assistance Plan ("LHAP"), outlining how SHIP funds will be used and the maximum SHIP funds allowable for each strategy under the LHAP; and

WHEREAS, the County desires to amend the LHAP to add a new strategy, Community Land Trust; and

WHEREAS, the SHIP Rules and Regulations require the County to submit an amendment to the LHAP to the Florida Housing Finance Corporation ("Corporation") for review and approval when a new strategy is added to the LHAP, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. That the Board approves amending the LHAP for the State's Fiscal Years 2018 and 2019, to add a new strategy, Community Land Trust, authorizes the County Administrator to submit an amended LHAP to the Corporation for review and approval, and authorizes the County Administrator to execute any necessary documents required by the State of Florida relating to the amended LHAP in accordance with the SHIP Rules and Regulations.

Section 2. <u>SEVERABILITY</u>.

If any portion of this Resolution is determined by any Court to be invalid, the invalid portion shall be stricken, and such striking shall not affect the validity of the remainder of this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies), property(ies),

or circumstance(s), such determination shall not affect the applicability hereof to any
other individual, group, entity, property, or circumstance.
Section 3. <u>EFFECTIVE DATE</u> .
This Resolution shall become effective upon adoption.
