- 3. The Scope of Services (**Exhibit A**) of the Agreement are unchanged and shall remain in full force and effect.
- 4. The Deliverables (**Exhibit A**) of the Agreement are unchanged and shall remain in full force and effect.

All provisions, covenants, terms and conditions of the Agreement between the Parties theretofore entered on September 29th, 2016, as originally set forth therein, which are not hereby expressly amended or modified and not in conflict with the terms hereof, are hereby ratified and confirmed and shall remain the same and be unaffected by these presents.
