

1 RESOLUTION DIRECTING THE COUNTY ADMINISTRATOR  
2 TO PUBLISH NOTICE OF PUBLIC HEARING TO CONSIDER  
3 ENACTMENT OF AN ORDINANCE

4 BE IT RESOLVED by the Board of County Commissioners of Broward County,  
5 Florida, that:

6 Section 1. The County Administrator in and for Broward County, Florida, and  
7 Ex-Officio Clerk of the Board of County Commissioners of Broward County is authorized  
8 and directed to publish notice of intent of the Board of County Commissioners of Broward  
9 County to consider at public hearing on Tuesday, May 8, 2018, at 10:00 a.m., the  
10 enactment of an Ordinance to be entitled:

12 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,  
13 PERTAINING TO THE BROWARD COUNTY BUSINESS  
14 OPPORTUNITY ACT RELATING TO COUNTY  
15 PROCUREMENT AND CONTRACTING OPPORTUNITIES  
16 FOR COUNTY BUSINESS ENTERPRISES ("CBEs") AND  
17 SMALL BUSINESS ENTERPRISES ("SBEs"); AMENDING  
18 SECTIONS 1-81 THROUGH 1-81.8 AND CREATING A NEW  
19 SECTION 1-81.9 OF THE BROWARD COUNTY CODE OF  
20 ORDINANCES ("CODE"); AMENDING DEFINITIONS;  
21 ALLOWING ADDITIONAL TIME FOR BIDDERS TO  
22 DEMONSTRATE COMPLIANCE WITH CBE GOALS  
23 DURING THE PROCUREMENT PROCESS; CLARIFYING  
24 REQUIREMENTS FOR BIDDERS TO ESTABLISH GOOD  
FAITH EFFORTS TO MEET CBE GOALS; UPDATING CBE  
AND SBE CERTIFICATION STANDARDS; AMENDING  
ENFORCEMENT PROVISIONS; AND PROVIDING FOR  
SEVERABILITY, INCLUSION IN THE CODE, AND AN  
EFFECTIVE DATE."
