The Board of County Commissioners of Broward County, Florida 23 ("Board"), hereby approves and authorizes the Mayor to execute a JPA with FDOT, 24 District 4, in substantially the form attached as Exhibit 1, for FDOT to provide funding for

limited stop bus service from the Sawgrass Mills Mall Park and Ride to Broward Central 2 Terminal in the amount of Five Hundred Thousand Dollars (\$500,000) granted under 3 Financial Project No. 440262-1-84-01. The Board authorizes the County Administrator to take all 4 Section 2. necessary administrative and budgetary actions to implement the JPA, including signing 5 any necessary time extensions. 6 7 Section 3.
