3 A RESOLUTION OF THE BOARD OF COUNTY
4 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
5 AUTHORIZING THE MAYOR TO EXECUTE A JOINT
6 PARTICIPATION AGREEMENT WITH THE FLORIDA
7 DEPARTMENT OF TRANSPORTATION, DISTRICT 4, IN THE
8 AMOUNT OF FIVE HUNDRED THOUSAND DOLLARS
9 (\$500,000), TO PROVIDE FUNDING FOR LIMITED STOP BUS
10 SERVICE FROM THE SAWGRASS MILLS MALL PARK AND
11 RIDE TO BROWARD CENTRAL TERMINAL; AUTHORIZING
12 THE COUNTY ADMINISTRATOR TO TAKE NECESSARY
13 ADMINISTRATIVE AND BUDGETARY ACTIONS; AND
14 PROVIDING FOR AN EFFECTIVE DATE.

15 WHEREAS, pursuant to Chapter 341, Florida Statutes, the Florida Department of
16 Transportation ("FDOT") provides funding for intercity bus service programs; and

17 WHEREAS, Broward County is a recipient of such funds; and

18 WHEREAS, FDOT has approved Five Hundred Thousand Dollars (\$500,000) in
19 funding for limited stop bus service from the Sawgrass Mills Mall Park and Ride to
20 Broward Central Terminal; and

21 WHEREAS, the Joint Participation Agreement ("JPA") must be approved by the
22 Board of County Commissioners of Broward County, Florida, NOW, THEREFORE,

23 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
24 BROWARD COUNTY, FLORIDA:

Section 1. The Board of County Commissioners of Broward County, Florida
("Board"), hereby approves and authorizes the Mayor to execute a JPA with FDOT,
District 4, in substantially the form attached as Exhibit 1, for FDOT to provide funding for

1 limited stop bus service from the Sawgrass Mills Mall Park and Ride to Broward Central
2 Terminal in the amount of Five Hundred Thousand Dollars (\$500,000) granted under
3 Financial Project No. 440262-1-84-01.

4 Section 2. The Board authorizes the County Administrator to take all
5 necessary administrative and budgetary actions to implement the JPA, including signing
6 any necessary time extensions.

7 Section 3. EFFECTIVE DATE.

8 This Resolution shall become effective upon adoption.
