RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY. APPROVING THE CONVEYANCE OF CERTAIN PARCELS COUNTY-OWNED THE LAND TO TOWN LAUDERDALE-BY-THE-SEA FOR RIGHT-OF-WAY PURPOSES; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, Broward County ("County") owns title to certain parcels of real property located in Lauderdale-By-The-Sea, Florida, identified as folio numbers 4943-07-00-0420 and 4943-18-01-4160 (the "Properties"), as more particularly described in the legal descriptions within the quitclaim deeds, attached hereto and made a part hereof as Attachment 1 ("Quitclaim Deed A") and Attachment 2 ("Quitclaim Deed B"); and

WHEREAS, the Town of Lauderdale-By-The-Sea ("Town"), a Florida municipal corporation, desires to acquire the Properties for right-of-way purposes; and

WHEREAS, the Town Commission of the Town of Lauderdale-By-The-Sea, at a regular meeting held on March 27, 2018 ("Town Commission Meeting"), authorized the Town Manager to notify the County that the Town will accept the conveyance of the Properties for right-of-way purposes, and to execute any necessary documents for such conveyance; and

1	WHEREAS, pursuant to the Town Commission Meeting, the Town Manager gave
2	the County written notification of the Town's intent to accept the conveyance of the
3	Properties for right-of-way purposes; and

5	WHEREAS, Section 335.0415, Florida Statutes, provides that public roads, with
6	the mutual agreement of the affected governmental entities, may be transferred
7	between jurisdictions; and

9	WHEREAS, the Board of County Commissioners of Broward County, Florida
10	("Board"), has determined that the conveyance of the Properties to the Town for right-of-
11	way purposes serves a public purpose and is in the best interest of the County, NOW,
12	THEREFORE,

14	BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
15	BROWARD COUNTY, FLORIDA:

17	Section 1. The recitals set forth in the preamble to this Resolution are true,
18	accurate, and incorporated by reference herein as though set forth in full hereunder.

20	Section 2. The Board authorizes the conveyance of the Properties to the Town
21	for right-of-way purposes.

23	Section 3. The Board authorizes the Mayor or Vice-Mayor of the Board to
24	execute Quitclaim Deed A, in the form of the attached Attachment 1, and Quitclaim

Deed B, in the form of the attached Attachment 2, and the County Administrator to attest to the execution. Section 4. Quitclaim Deed A and Quitclaim Deed B shall be properly recorded in the Public Records of Broward County, Florida. Section 5. SEVERABILITY. If any portion of this Resolution is determined by any Court to be invalid, the invalid portion shall be stricken, and such striking shall not affect the validity of the remainder of this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies), property(ies), or circumstance(s), such determination shall not affect the applicability hereof to any other individual, group, entity, property, or circumstance.
