12	WHEREAS, Section 336.025, Florida Statutes, authorizes county governments to		
13	levy various local option fuel taxes upon every gallon of motor fuel and diesel fuel sold in		
14	the county and taxed under the provisions of Part I or Part II of Chapter 206 of the Florida		
15	Statutes; and		
16	WHEREAS, in 1988, the Board of County Commissioners of Broward County,		
17	Florida ("Board"), levied a six-cent (\$0.06) local option gas tax on every gallon of motor		
18	fuel and special fuel sold in Broward County for a maximum period of thirty (30) years;		
19	and		
20	WHEREAS, Section 31½-34 of the Broward County Code of Ordinances ("Code"),		
21	which imposes the above-referenced levy of the six-cent (\$0.06) local option gas tax,		
22	expires on August 31, 2018; and		
23	WHEREAS, Broward County and the eligible municipalities representing a majority		
24	of the population of the incorporated area within the County have executed a new

1	interlocal agreement ("ILA") establishing the method of distributing the proceeds of the
2	six-cent (\$0.06) local option gas tax from September 1, 2018, through December 31,
3	2047; and
4	WHEREAS, the Board desires to amend Sections 31½-34 and 31½-35 of the Code
5	to relevy the six-cent (\$0.06) local option gas tax and reestablish the distribution formula
6	from and including September 1, 2018, through December 31, 2047; and
7	WHEREAS, the Board finds that the revisions to the Code as set forth herein are
8	necessary and in the best interest of Broward County,
9	
10	BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
11	BROWARD COUNTY, FLORIDA:

13	Section 1. Section 31½-32 of the Broward County Code of Ordinances is
14	hereby amended to read as follows:
15	Sec. 31½-32. Imposed.
16	There is hereby imposed a six-cent (\$0.06) local option gas tax upon every gallon
17	of motor fuel and special diesel fuel sold in Broward County and taxed under the
18	provisions of Chapter 206, Florida Statutes, which tax shall be imposed for the period of
19	time provided for in Section 31½-34 of this article.

21	Section 2. Section 31½-33 of the Broward County Code of Ordinances is
22	hereby amended to read as follows:

Sec. 31½-33. Intent.

It is the intent of this division that the funds generated by the imposition of the initial local gas tax on motor fuel and special diesel fuel are to be used only for "transportation expenditures" as defined by § Section 336.025(7), Florida Statutes.

Section 3. Section 31½-34 of the Broward County Code of Ordinances is hereby amended to read as follows:

Sec. 31½-34. Effective dates of tax.

The six-cent (\$0.06) local option gas tax imposed by sSection 31½-32 shall be effective from September 1, 1998, to August 31, 2018, both inclusive and including September 1, 2018, through December 31, 2047.

Section 4. Section 31½-35 of the Broward County Code of Ordinances is hereby amended to read as follows:

Sec. $31\frac{1}{2}$ -35. Distribution of tax.

(a) The proceeds of the six-cent (\$0.06) local option gas tax hereby imposed shall be divided and distributed by the State of Florida Department of Revenue, with Sixtytwo and Fifty One-hundredths one-half percent (62.50%) of the proceeds thereof distributed to the County and Thirty-seven and Fifty One-hundredths one-half percent (37.50%) of the proceeds thereof distributed to the eligible municipalities in accordance with the distribution formula set forth in the interlocal agreements which shall be amended each year prior to July 1, between Broward County and the eligible municipalities located in Broward County representing a majority of the incorporated area population within Broward County. With regard to the proceeds to be distributed to the eligible municipalities:

1	<u>(1)</u>	Such distribution shall be based upon the annual Bureau of Economics and
2		Business Research ("BEBR") population figures for each eligible
3		municipality as of April 1 of each year.
4	<u>(2)</u>	By July 1 of each year, the County shall forward the finalized BEBR
5		population figures to the State of Florida Department of Revenue for the
6		purpose of distributing the eligible municipalities' share of the proceeds of
7		the local option gas tax.

10	Section	on 5. <u>CERTIFIED COPY OF THE ORDINANCE</u> .
11	A cer	tified copy of this Ordinance shall be furnished to the State of Florida
12	Department	of Revenue within ten (10) days after enactment of this Ordinance.

14	Section	on 6. <u>SEVERABILITY</u> .
15	If any	portion of this Ordinance is determined by any Court to be invalid, the invalid
16	portion shall	be stricken, and such striking shall not affect the validity of the remainder of
17	this Ordinand	ce. If any Court determines that this Ordinance, or any portion hereof, cannot
18	be legally	applied to any individual(s), group(s), entity(ies), property(ies), or
19	circumstance	e(s), such determination shall not affect the applicability hereof to any other
20	individual, gr	oup, entity, property, or circumstance.
