I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

Broward County operates the general-purpose Foreign-Trade Zone #25 (FTZ#25) under a Grant of Authority from the Foreign-Trade Zones Board in Washington, D.C., and is required by law and regulation to maintain an Inventory Control and Recordkeeping System (ICRS) capable of tracking all movements of foreign merchandise through the FTZ #25. Growing, high-volume, complex general-purpose Foreign-Trade Zones, such as Broward County's FTZ#25, require an automated ICRS to operate with cost-effective and user-friendly efficiency.

The product/service that we are seeking is "Software-as-a-Service" (web-based access/service not run on the County's servers and operating systems) that provides automated processing and recording of data related to the admission, tracking, and transfer of foreign and domestic merchandise moving in/out of the activated facilities of FTZ#25; provide reporting capabilities that will enhance the ability of the FTZ Operator to control and manage activities in FTZ#25; allow limited input/access to participating FTZ User companies to input/access their data; satisfy FTZ User/CBP requests for reports and ad hoc information; provide backed-up data storage and secure processing related to inventory movements; and, provide FTZ Users with timely Customs permitting processes related to their merchandise import / export responsibilities. FTZ#25 has been automated since the 1980's. In 1999, our original "in-house" FTZ ICRS software (not Y2K compliant and too expensive to re-develop "in-house") was replaced by the leading "off-the-shelf" FTZ ICRS software available at

the time. Over the next seven (7) years, that FTZ ICRS software proved to be incompatible with Broward County's growing FTZ #25 project, not "user-friendly", and over-priced (the software provider sought to unfavorably alter their original pricing, contractual interpretations and arrangements). Customer satisfaction (from our valuable FTZ #25 Users and Tenants) suffered from that software's short-comings. In 2007, we replaced that unsatisfactory software with our current FTZ ICRS software, *EZ-FTZ* by Homedata (Rochester), Inc. This software provider has been very responsive in fully improving the functionality and reporting capability for FTZ management / FTZ Users / U.S. Customs & Border Protection. Similarly, the capacity and pricing of the current software, especially for remote sites, has contributed to the growth of the FTZ because each new FTZ User did not need to purchase a separate software license at additional cost in order to use the software.

Unfortunately, Homedata (Rochester), Inc., was sold to a competitor, resulting in the phasing-out of *EZ-FTZ* software which will no longer be supported under our existing FTZ Software Agreement after September, 2018. Therefore, that software must be replaced with available software that meets the current and future needs of Broward County's FTZ program (both Port and multiple remote sites). And, in order to allow time for transition planning, setup, training, data transfer, implementation, etc., new FTZ ICRS software will need to be purchased as soon as possible.

Staff has researched the evolved marketplace for alternative "off-the-shelf" FTZ ICRS software and has confirmed that a mature "Software-as-a-Service" provider has risen to national prominence offering a product which is most suitable to our FTZ operations. A comprehensive evaluation of alternatives in the marketplace has identified only one software package and vendor, *Integration Point FTZ* software by Integration Point, Inc., which best meets the specific requirements of Broward County's Foreign-Trade Zone #25 and is most capable of providing a smooth transition from *EZ-FTZ* software. *Integration Point FTZ* software is used at multiple FTZs across the U.S. and has a proven track record. Integration Point, Inc., is a proprietary vendor offering the essential FTZ software and implementation expertise (data migration and training) required by this Department. *Integration Point FTZ* software, which has significant flexibility and functional advantages, would be utilized as "Software-as-a-Service"; provide reporting capabilities that will enhance the ability of the FTZ Operator to manage FTZ#25 and satisfy FTZ User/CBP requests for information; provide backed-up data storage and secure processing; and, provide FTZ Users with voluntary access to a wide range of other import / export functionalities and services at their own expense. The software has a superior reputation in the category of user-friendliness—a critical element in satisfying the FTZ end-users—and has functionality consistent with Broward County's methodologies, without compromising elements of the FTZ program and its effectiveness. It is anticipated that minimal modifications will be needed to this off the shelf package, i.e. complex password, per County standards.

Integration Point, Inc., being the owner of Homedata (Rochester), Inc., since its takeover, is the owner of our current FTZ software (*EZ-FTZ*), employs the same former Homedata (Rochester), Inc., employees who transitioned us onto *EZ FTZ* (from our previous FTZ software), and have been expert at servicing our current FTZ software for the last ten years. These same employees and others within Integration Point, Inc., are also expert at supporting *Integration Point FTZ* software. No other company employs such a team of experts in both FTZ software. They have extensive experience in setting up, transferring data, and training for other FTZs transitioning from *EZ-FTZ* to *Integration Point FTZ*. No other company has the experienced employees who have worked with our unique and complex FTZ over the last ten years. This advantage is unique to Integration Point, Inc., as a vendor and will lead to a most efficient, timely, and trouble-free transition from *EZ-FTZ* to *Integration Point FTZ* for all of our FTZ Users. Such transitions are difficult enough on the daily operations of our FTZ operations and those of our FTZ Users. The better executed by the FTZ software vendor, the more satisfied will be our FTZ Users with our FTZ program. As detailed above, this will be the third time we have put our FTZ Users through FTZ software transitions. We need it to go well with as little as possible damage to our reputation for convenient and efficient FTZ customer service.

Integration Point, Inc.'s FTZ software, both *EZ-FTZ* and *Integration Point FTZ* software, are widely used by most of the FTZs in the U.S. and Integration Point has always maintained their software to a high standard of compliance with all rules, regulations, and laws governing FTZs. They have been highly proficient at automatically upgrading their product as changes occur in the regulatory environment.

Replacement software must be procured as soon as possible to avoid an interruption in FTZ services. If the current software is not replaced as expeditiously as possible, mounting customer dissatisfaction will damage the reputation of FTZ#25 as a well-run and cost-effective Foreign-Trade Zone. Otherwise, there may emerge a need for additional staff to operate the FTZ to avoid the potential for fines and/or penalties from Customs & Border Protection for poor ICRS performance. Or, worse, FTZ Users may go to other competing FTZs in the region resulting in the loss of jobs, investment, and revenue in/for the County.

The software investment for these services will be provided Integration Point, Inc., at an estimated cost of \$650,000. The cost is based on an initial Subscription/License Fee, Software Training, Set-up, and Data Transfer of approximately \$150,000, and Annual Transaction Processing, Maintenance and Tech Support of \$50,000 (covering 10 years). These costs will be recovered over the term through charges billed to FTZ Users in the FTZ Tariff. Port Everglades Department considers the estimated cost fair and reasonable, based on the cost of the currently-used FTZ software's license, implementation, and technical and consulting services, linkage development, data migration, annual support services and the cost of similar products on the market. The 10-year term was chosen to insure that FTZ#25 and all of its FTZ Users will be assured of the stability of FTZ services utilizing the same FTZ software. More frequent transitions are too disruptive, reduce customer satisfaction, and are detrimental to efficient FTZ operations.

These same employees and others within Integration Point, Inc., are also familiar and/or expert at supporting *Integration Point FTZ* software. No other company employs such a team of experts in both FTZ software. They have extensive experience in setting up, transferring data, and training for other FTZs transitioning from *EZ-FTZ* to *Integration Point FTZ*. No other company has the experienced employees who have worked with our unique and complex FTZ over the last ten years. This advantage is unique to Integration Point, Inc., as a vendor and will lead to a most efficient, timely, and trouble-free transition from *EZ FTZ* to *Integration Point FTZ* for all of our FTZ Users. Such transitions are difficult enough on the daily operations of our FTZ operations and those of our FTZ Users. The better executed by the FTZ software vendor, the more satisfied will be our FTZ Users with our FTZ program.

While other software vendors may offer competitive "Software-as-a-Service processing", the pricing for transitioning FTZ#25 (implementation, technical and consulting services, linkage development, data migration, annual support services) will be much higher considering their unfamiliarity with our complex, high volume, FTZ Users. Other vendors would require much more time and expense coming to understand the complexity of FTZ#25, with its sixteen Broward County sites and multiple private business FTZ Users, and its high volume, quick-turn-around U.S. Customs processing. Most vendors sell their FTZ software to single company FTZs which requires much less implementation costs on their part. Pricing a project like ours will cost them and the County substantially more due to our FTZs complexity—something Integration Point, Inc., already has done and has ten years of familiarity. The learning curve for the vendor will be steeper as well as their costs. Mistakes and delays will be detrimental to the operations of our participating FTZ Users resulting in business losses and erosion of their FTZ benefits. That in turn may lead to the loss of jobs, investment, and revenue in/for the County. Additional County staff or overtime will likely be needed to maintain and operate the FTZ to avoid the potential for fines and/or penalties from Customs & Border Protection for poor ICRS performance.

Additional Information:

The Purchasing Agent recommends an Only Reasonable Source designation for Integration Point FTZ Software platform for the following reasons:

Broward County's Foreign Trade Zone (FTZ) No. 25 is very unique and the largest FTZ in Florida, and the third largest in the United States for exports (Exhibit 4). The uniqueness of the County's FTZ contains nineteen (19) remote FTZ sites, twenty (20) private company users, and five (5) subzones that are stakeholders in the complex fast moving system of receiving, inventory tracking, reporting, and exporting various types of merchandise worth multiple millions of dollars on an annual basis.

The current contract (A0739206A1_1; Homedata (Rochester) Inc., EZ-FTZ) expires on September 15, 2018. Homedata (Rochester), Inc. was acquired by Integration Point, Inc. in 2010.

Because of the complexity and size of Broward County's Foreign Trade Zone (FTZ) No. 25 and all of its designated users, advanced record keeping, and regulatory compliance, I recommend transitioning into and implementing a system that is most similar to the County's existing EZ-FTZ software system and also to maintain the same key personnel who were formerly with Homedata (Rochester), Inc., who are currently maintaining Port Everglades' EZ-FTZ Software system (Exhibit 2). The key personnel have years of intimate knowledge of the current EZ-FTZ system and working relationships with the County's FTZ staff. The end of life support for Integration Point's EZ-FTZ software is September 19, 2019. Homedata (Rochester), Inc. was acquired by Integration Point, Inc. in 2010 (Exhibit 6). Integration Point, Inc. has implemented a current FTZ software system at FTZ No. 68 in Texas. FTZ No. 68 is the only other FTZ nationwide that is comparable to the County's FTZ in complexity and designated users, but is a smaller size FTZ. The delicate balance of the County's FTZ requires a near seamless transition and conversion to another software system in order to maintain stability and mitigate any potential loss of revenue for all stakeholders in the County's FTZ.

There will be NO cost in transitioning from the current EZ-FTZ system to the new Integration Point FTZ system (Exhibit 5). Also, a decreased level of effort will be required from Integration Point when converting over from the current EZ-FTZ system to the new Integration Point system as compared to implementing a completely new software system from another vendor. This will yield a substantial savings in cost, time and

learning for the County and the users of the FTZ.

The same key personnel that is maintaining the current EZ-FTZ system will also implement and maintain the new Integration Point system if Integration Point is awarded a contract and the County inserts the names of the key personnel into the Agreement. Considering how robust and a great capacity for growth that the Integration Point system has; This is the only solution that could potentially replace EZ-FTZ. Both solutions are from Integration Point. Both the EZ-FTZ solution and Integration Point's FTZ solution will need to run and operate simultaneously to insure a trouble free transition. As stated earlier, there would be no cost to the County for transitioning into the new system.

Port Everglades staff has researched and indicated that other similar types of FTZ software do not compare with the system provided by Integration Point (Exhibit 1, Exhibit 8). The other FTZ software systems are more for single type companies, and not developed for Port Everglades complex multiple user type system. The SmartZone FTZ software system was adequate for a time, but later found the provider not responding well for service. Also the SmartZone system could be expandable, but at a greater amount of effort with uncertainty. County staff has also indicated that the system provided by Integration Point is much more robust in tracking and reporting capabilities, and has the capacity for expansion. Port Everglades FTZ is expanding and growing therefore needing a system that has the capability to add designated FTZ users. This will in turn a greater economic atmosphere in Broward County creating jobs and providing support for the Board of County Commissioner goal to "Increase the economic strength and impact of revenue-generating County enterprises balancing economic, environmental, and community needs". The County currently receives \$365,000 per year of direct revenue; and approximately \$110,000,00 of indirect/residual revenue as a result of the FTZ operations (Exhibit 3).

History:

On September 11, 2007 (Item No. 33), the Board approved the Agreement with HOMEDATA (Rochester), Inc. to provide foreign-trade zone (FTZ) inventory control and record-keeping software (EZ-FTZ) and the licensing and maintenance of the software. The cost of the software license, including initial services and the first year's maintenance was \$200,000. The term of the Agreement began on the date of execution and, with a five year option period, ended six years after the Final Acceptance date. The Final Acceptance date was September 11, 2008.

On September 9, 2014 (Item No. 11), the Board approved a Second Amendment, which extended the term of the existing Agreement with HOMEDATA (Rochester) Inc. for one year effective September 11, 2014, and provided an additional 100 hours of support and/or training, under the same terms and conditions as set forth in the original Agreement. During negotiations for the Second Amendment, HOMEDATA (Rochester) Inc. was only interested in a one year extension because they were not sure how long they would continue to support EZ-FTZ. Subsequently, HOMEDATA (Rochester) Inc. has informed staff that they would be willing to negotiate a three-year extension for support services.

On June 9, 2015 (Item No. 70), the Board approved the Director of Purchasing to negotiate, approve and execute a Third Amendment to the existing Software License Agreement between Broward County and HOMEDATA (Rochester) Inc., to continue software support for EZ-FTZ software at Broward County's Port Everglades Foreign-Trade Zone No. 25 for up to three one year extensions commencing September 11, 2015, with a not-to-exceed value for software support and any additional services of \$75,000.

As a 35-year Operator of FTZs and member of the National Association of Foreign-Trade Zones (NAFTZ), I have had the opportunity to witness the development of the FTZ software industry. In Texas, circa 1990, we (FTZ#68) bought and used the first such FTZ software available. Most FTZs were not automated and/or had developed their own internal FTZ software as a part of their business accounting systems. That is still true today for the larger FTZ Operators who tend to be just one stand-alone site / company operation (i.e., manufacturing plant, distribution center). Medium and small size FTZ operations, single stand-alone sites / company operations, tend to buy off-the-shelf FTZ software to augment their business accounting system specifically to meet the special type of inventory control, recordkeeping, and transaction

processing that is required by FTZ rules, regulations, and statutes. FTZ#25 operates for multiple sites / companies, large and small, manufacturing and distribution, and requires a very robust and accommodating FTZ Software. The choices of such FTZ software in the marketplace are few. Today, the market is dominated by just three – *SmartZone*, *QuestWeb*, and *Integration Point* (EZ-FTZ no longer sold). Each year, I attend national conferences and expositions where the available FTZ software providers are present marketing their products with detailed promotions and demonstrations. In addition, I serve on the NAFTA Automation Committee which teleconferences regularly to discuss the problems and challenges of the FTZ industry, including the interface of FTZ software with that of the recently promulgated electronic interface system of U.S. Customs - Automated Commercial Environment (ACE).

Up until 2000, Broward County's FTZ#25 was operated with FTZ software (PIC) developed "in-house". By Y2K, we could no longer support it and purchased *SmartZone*. The transition was formidable since we had several FTZ User companies requiring separate and secure databases. Soon after that, FTZ#25 added several more FTZ User companies, larger and more complex, **exceeding the capabilities (and cooperation) of SmartZone. Please provide hard documentation supporting the prior in green.** While there may be more documentation somewhere (over months the PE Director of Business Administration – Pia Thompson, PE Director of Finance – Mary Menares, Director of Information Technology – Loretta Malmstrom, PE Port Attorney – Russell Morrison, and FTZ Operator – Robert Jacob exchanged many communications regarding the lack of support and the existence of *SmartZone* FTZ software flaws with the owner of *SmartZone* FTZ software), I have only so far found the attached (Part of ETS Project # 219558 to Replace *SmartZone* FTZ software with EZ-FTZ) In 2008, we purchased EZ-FTZ (owned by HomeData (Rochester), Inc.). The transition was very challenging but very productive leading to much greater customer service, automated efficiencies, and electronic interface with U.S. Customs. EZ-FTZ has continued to serve the needs of FTZ#25 excellently to this day. Unfortunately, EZ-FTZ was purchased by a competing FTZ software provider (Integration Point, Inc.) and will no longer be supported beyond September, 2018. **Why will EZ-FTZ no longer be supported? Homedata (Rochester) Inc. (owner of our current version of FTZ software (EZ-FTZ)) was bought by a competing FTZ software provider (Integration Point, Inc.) who markets and supports their own version of FTZ software (Integration Point) and they have decided to no longer support EZ-FTZ in favor of their own FTZ software (Integration Point).** Therefore, we must transition to another FTZ software as soon as possible. Since FTZ#25 has added, and will continue to add, more FTZ User companies into the future, *SmartZone* and EZ-FTZ are not viable choices. That leaves *QuestWeb* and *Integration Point*.

QuestWeb is used at a number of individual small or large manufacturing or distribution FTZ companies. Its provider has experience transitioning such individual FTZ companies from their existing FTZ software, including EZ-FTZ, to *QuestWeb*. However, they have not transitioned an active, multi-company, large and small, manufacturing and distributing FTZ (such as our FTZ#25) from another FTZ software to its FTZ software. **Please provide hard documentation supporting the prior statements in green .** None available (Only FTZ#25 and FTZ#68 are operated similarly)

Integration Point, Inc., the owner and support provider for both EZ-FTZ and *Integration Point*, not only has the experience of transitioning 250 FTZ companies of all kinds from their existing FTZ software, including 70 from EZ-FTZ, to *Integration Point*. In addition, the same programming and support staff (formerly with HomeData (Rochester), Inc.) who performed the transition of FTZ#25 from *SmartZone* to EZ-FTZ in 2008 are now employed at Integration Point, Inc. They are all personally familiar with our staff, our multiple FTZ companies, our multiple FTZ activities, and currently provide support for our complex, multiple-company database activity and our growth. Being expert in both EZ-FTZ and *Integration Point*, they are in a position to make the most accurate, efficient, cost-effective and accommodating FTZ software transition for FTZ#25.

These same employees and others within Integration Point, Inc., are also expert at supporting Integration Point FTZ software. No other company employs such a team of experts in both FTZ software. They have extensive experience in setting up, transferring data, and training for other FTZs transitioning from EZ-FTZ to Integration Point FTZ. No other company has the experienced employees who have worked with our unique and complex FTZ over the last ten years." **What guaranty does Broward County have that the same employees who are familiar with the current FTZ software will also be the same key personnel if Broward County awards to Integration Point? Do you have the current personnel names that are familiar with and have experience with Broward County's FTZ software? Ruth Tjostheim, Liz Connell, Dave Dill, and Phillip Ewing form the core of those intimately familiar with FTZ#25**

For clarification, is EZ-FTZ software and Integration Point FTZ software exactly the same? If not, could you please state the differences? They are two separate and distinct software programs that perform the same core functions of inventory control, recordkeeping, and U.S. Customs permit processing required to satisfy the rules, regulations, and requirements of U.S. Foreign-Trade Zones (19 CFR., Part 146 and 15 CFR 400). Each have different screen appearances, work flows, formats, etc., but perform the same processes required by law to keep track of all merchandise entering, leaving, and manipulated/manufactured in the active FTZ facilities.

"Integration Point, Inc.'s FTZ software, both EZ-FTZ and Integration Point FTZ software, are widely used by most of the FTZs in the U.S...." **Do you have any documentation supporting this statement? Hi Karen –

As discussed, the FTZ software utilized by the County is a critical element of our operation. For context: our zone is the third largest in the U.S. in terms of exports. During FY2015, \$291M worth of merchandise was received and \$295M was forwarded. The average on-hand inventory value was, on average, \$23M; consisting of 710 HTS classifications (20,000+ part numbers) from 144 different countries. Without the FTZ software in place, the international operations of 15 companies—plus the ones we are in the process adding—will come to a standstill.

The volume and complexity of merchandise passing through the FTZ is high and unique—we believe there is maybe one other FTZ in the U.S. that operates the way we do. Therefore, it is critical that the FTZ replacement procurement project be completed in a timely manner to allow for a smooth transition. We strongly advise to have to have the procurement is completed by January 2018.

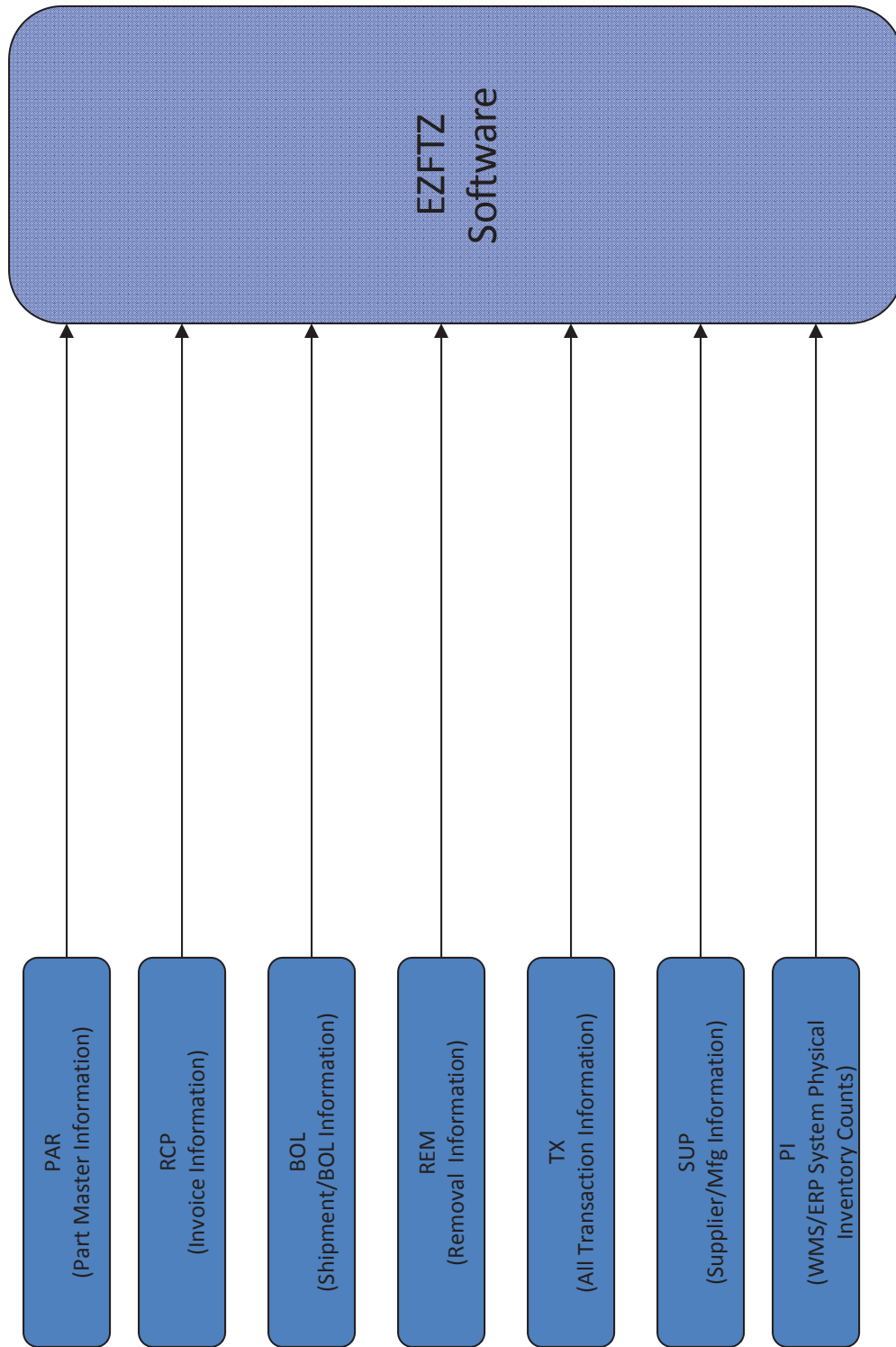

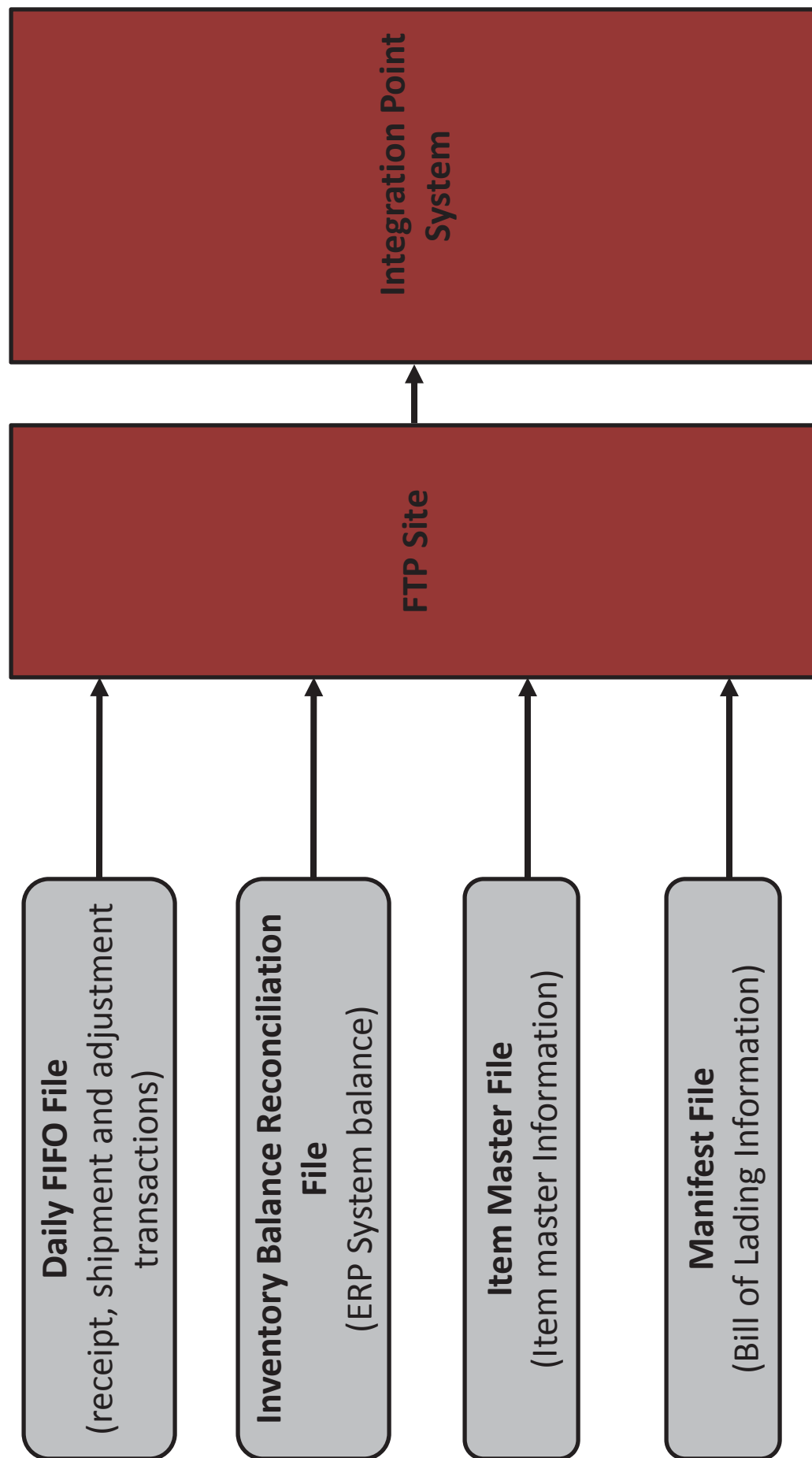

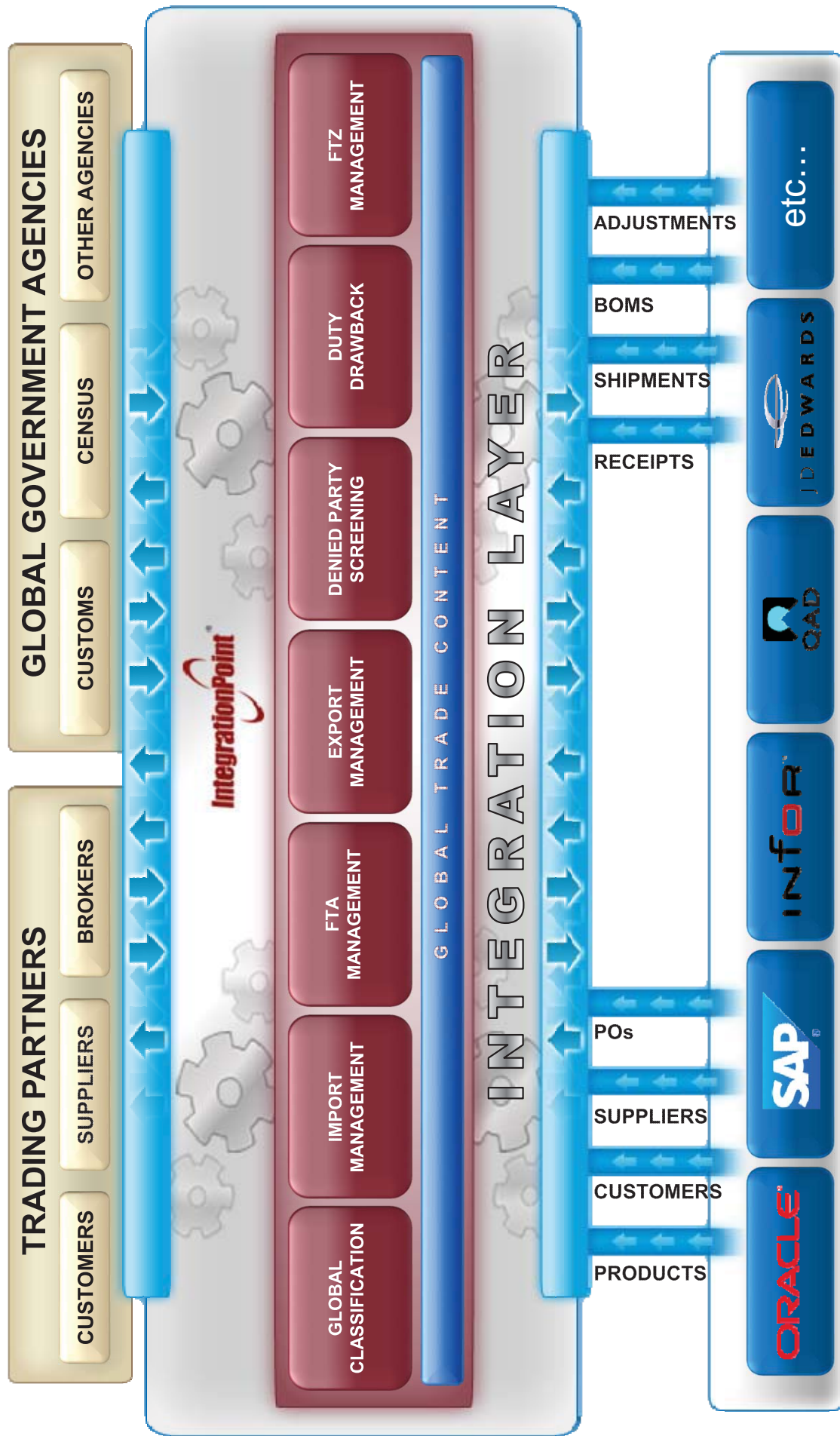

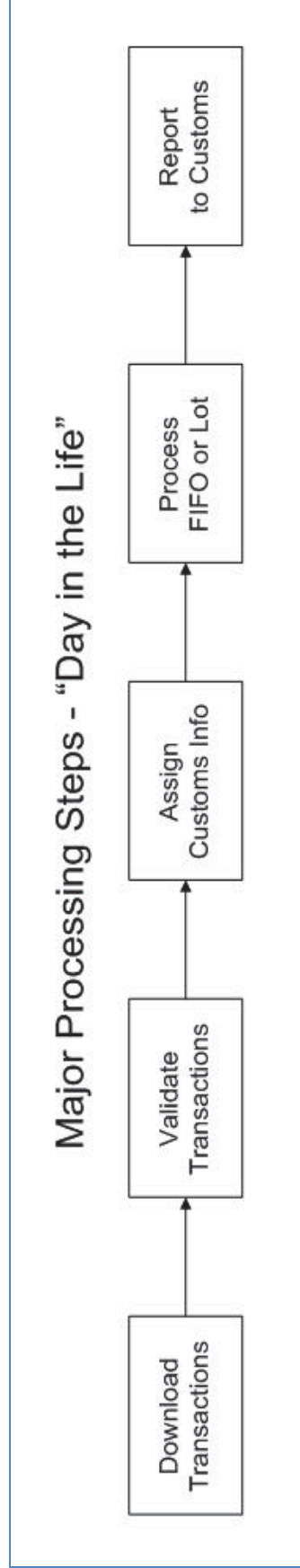
