The Office of Economic and Small Business Development (OESBD) conducted a review of the respondents' compliance with the CBE Program requirements for the above referenced project. An overview is provided as follows:

Compliance Comments:

Lanzo Construction Co., Florida submitted the required documentation in accordance with the solicitation's requirements and is compliant with the CBE program requirements.

Ric-Man Construction, Inc. initially submitted incomplete Letters of Intent (LOIs) for this solicitation. The firm was given three (3) business days to provide complete LOIs or documentation demonstrating their good faith efforts to meet the goal. Ric-Man Construction, Inc. submitted the completed LOIs within the timeframe and therefore is compliant with the CBE program requirements for the solicitation.

Ric-Man International, Inc. submitted incomplete LOI forms with the solicitation. The firm was given three (3) business days to provide complete LOIs and/or supporting documentation demonstrating their good faith efforts to meet the CBE goal. Ric-Man International, Inc. submitted completed LOIs for 19.7% CBE commitment and supporting documentation demonstrating their good faith efforts to meet the goal. Upon review of the good faith effort, OESBD has determined that the firm did not met the quality, quantity and extent in their various efforts to meet the goal in accordance with Section 1-81.5 of the Broward County Business Opportunity Act of 2012. Therefore, the firm is non-compliant with the CBE requirements of the solicitation.

Giannetti Contracting Corporation submitted two (2) completed LOI forms with the solicitation. However, the firm's CBE commitment was less than the 30% CBE goal requirements. The firm was given three (3) business days to provide any additional LOIs and/or supporting documentation demonstrating their good faith efforts to meet the CBE goal. Giannetti Contracting Corporation submitted supporting documentation demonstrating their good faith efforts to meet the goal. Upon review of the good faith effort, OESBD has determined that the firm did not meet the quality, quantity and extent in their efforts to meet the goal in accordance with Section 1-81.5 of the Broward County Business Opportunity Act of 2012. Therefore, the firm is non-compliant with the CBE requirements of the solicitation.

Man-Con, Inc. submitted LOI forms for its' CBE subcontractors and supporting documentation demonstrating their good faith efforts to meet the goal with the solicitation. The firm's CBE commitment is 23.69% below the assigned 30% goal. Man-Con, Inc. submitted an LOI for Bon's Barricade for 2.69% CBE participation, however, the firm is not a certified CBE firm. Therefore, their participation cannot be counted. The firm was given three (3) business days to provide additional LOIs and/or supporting documentation demonstrating their good faith efforts to meet the CBE goal. Upon review of Man-Con, Inc.'s good faith effort, OESBD has determined that they did not meet the quality, quantity and extent in their various efforts to meet the goal for this solicitation in accordance with Section 1-81.5 (e) (3) of the Broward County Business Opportunity Act of 2012. Therefore, the firm is non-compliant with the CBE requirements of the solicitation.
