I. REQUEST: Provide a description of the features of the product/service or Scope of Work.

The Micro Focus COBOL Server and compiler tool is necessary for the ETS Cyborg team to efficiently manage the County's current Payroll/Human Resources/Position Control system which is used for processing bi-weekly employee payroll transactions. Continued maintenance of this product is of major importance, especially as the County makes plans to transition to the ERP Human Capital System. County has been licensed to use this product since 1997 which includes a number of generational upgrades. The compiler is used on a daily basis in the development of application source code allowing the County provide in-house maintenance, new enhancements and troubleshooting of Cyborg issues.

Our current Cyborg payroll system is supported by Micro Focus. The County anticipates a move from the Cyborg Payroll system to ERP HCM; eliminating the need for continued use of the Micro Focus product. It is estimated that the move to HCM will take place within the next five years.

As the sole proprietor of the Micro Focus support programs, it is understood that there are authorized resellers of the Micro Focus compiler. However, we feel that a direct relationship with the sole proprietor is beneficial to the County during the interim period in order to leverage the advantage in the relationship that we currently have with Micro Focus. Therefore, we are requesting approval of this Only Reasonable Source

procurement continuing use of this product until the sunset of the Cyborg payroll system.

The County's payroll em is ingrained in this software application; the County has been licensed to use the Micro Focus Server COBOL and has gone through several generational upgrades since 1997. If the County were to look to an alternate vendor or source the cost in County resources would be increased significantly along with need of a minimum of two years for implementation while at the same time causing a severe delay acting to the implementation of the ERP HCM.
