

RESOLUTION NO. 2018-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AUTHORIZING THE MAYOR TO EXECUTE A SUPPLEMENTAL JOINT PARTICIPATION AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION, DISTRICT 4, IN THE AMOUNT OF THREE MILLION EIGHT HUNDRED THIRTY THOUSAND FOUR HUNDRED EIGHTY-SIX DOLLARS (\$3,830,486), TO PROVIDE ADDITIONAL FUNDING FOR OPERATIONS AND MAINTENANCE OF INTERSTATE 95 EXPRESS BUS SERVICE; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE NECESSARY ADMINISTRATIVE AND BUDGETARY ACTIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 341.053, Florida Statutes, created the Intermodal Development Program administered by the Florida Department of Transportation ("FDOT"); and

WHEREAS, the Intermodal Development Program provides major capital investments for the construction of intermodal or multimodal terminals and to otherwise facilitate the intermodal or multimodal movement of people and goods; and

WHEREAS, Broward County is a recipient of Intermodal Development Program funds; and

WHEREAS, on September 10, 2015, Broward County and FDOT entered into a Joint Participation Agreement ("JPA") to provide funding for the operation and maintenance of Interstate 95 Express Bus Service for Fiscal Year (FY) 2015-16; and

WHEREAS, on August 29, 2016, and July 28, 2017, Broward County and FDOT entered into Supplemental Joint Participation Agreements ("SJPA's") to provide

1 additional funding for the operation and maintenance of Interstate 95 Express Bus
2 Service for FY 2016-17 and FY 2017-18 respectively; and

3 WHEREAS, FDOT has authorized Three Million Eight Hundred Thirty Thousand
4 Four Hundred Eighty-six Dollars (\$3,830,486) in additional funding for FY 2018-19 to
5 supplement the Eight Million Seven Hundred Eighty-one Thousand Seven Hundred
6 Thirty-four Dollars (\$8,781,734) previously granted under Financial Project Numbers
7 424219-2-84-01 and 424219-3-84-01 for a total of Twelve Million Six Hundred Twelve
8 Thousand Two Hundred Twenty Dollars (\$12,612,220) in funding for the project; and

9 WHEREAS, an SJPA must be approved by the Board of County Commissioners
10 of Broward County, Florida, NOW, THEREFORE,

12 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
13 BROWARD COUNTY, FLORIDA:

15 Section 1. The Board of County Commissioners of Broward County, Florida
16 (Board), hereby approves and authorizes the Mayor to execute an SJPA with FDOT,
17 District 4, in substantially the form attached as Exhibit 1, in the amount of Three Million
18 Eight Hundred Thirty Thousand Four Hundred Eighty-six Dollars (\$3,830,486) granted
19 under Financial Project Numbers 424219-2-84-01 and 424219-3-84-01, to provide FY
20 2018-19 funding for operations and maintenance of Interstate 95 Express Bus Service.

22 Section 2. The Board authorizes the County Administrator to take all
23 necessary administrative and budgetary actions to implement the SJPA.

2 This Resolution shall become effective upon adoption.
