Compliance Evaluation – Threshold Increase

The Office of Economic and Small Business Development (OESBD) has conducted an evaluation of Keolis Transit America's (Keolis') ACDBE participation for the Airport Shuttle Bus and Other Transportation Services Agreement. An overview of the evaluation is as follows:

The ACDBE goal was 15%.

Keolis committed to 15.30% ACDBE participation.

The proposed budget threshold increase will increase the contract amount by \$16,013,942. Total proposed agreement amount will be \$65,379,038.00.

Compliance Evaluation – Threshold Increase

ACDBE Compliance Comments:

The current level of ACDBE participation on the agreement is 11.91%. This level of attainment is 3.39% (15.30% - 11.91%) less than the management company's committed level of participation. Participation was verified through an independent payment verification process.

On March 12, 2018, OESBD received a correspondence from Keolis requesting the substitution of its ACDBE subcontractor, Maruti Fleet & Management, LLC (Maruti). OESBD approved the substitution on May 3, 2018. Keolis has since submitted a proposed plan of action, dated May 9, 2018, to meet its 15.30% ACDBE commitment for the remainder of the project. The plan proposes to replace Maruti with a new ACDBE subcontractor and add three new ACDBE subcontractors. The OESBD is currently in the process of reviewing this plan to ensure that the proposed subcontractors are eligible to be counted towards meeting Keolis' ACDBE commitment on the agreement.

The OESBD will continue to monitor this agreement for compliance with the requirements set forth in 49 CFR Parts 23 and 26 and Broward County's ACDBE Program Plan.
