Dear Mr. Campbell,

This letter responds to your Notice of Intent to Terminate Agreement for Cause dated December 19, 2017. This letter was delivered to us by certified and regular mail on December 27, 2017. While we disagree with many of the assertions in your letter, we remain committed to successfully completing this project so that we can receive payment for the work we have done. We would like to state that the Medical Examiner Roof was built in accordance to the specifications and drawings including the NOA requirements. In addition, we have passed and have finals for all city inspections, we have passed and acquired GAF product manufacturer inspections and GAF has approved a 20 Year Warranty.

Allied Contractors, Inc. proposes to install fasteners with 3" plates at 36" diameter throughout the entire perimeter and corners. The fasteners will penetrate the lightweight concrete and into the metal deck. We will then install torch applied modified smooth and finish with torch applied final layer of modified granule.

Please see below the steps in order to meet the negative pressure requirements:

- 1. Prime Perimeter Existing Granule Surface
- 2. Install 10" Drill-Tec #14 Fasteners/ Drill-Tec 3" Plates, mechanically fastened.
- 3. Mechanically install at perimeter 8" O.C. @ Lap #3 rows @ 8" O.C.
- 4. Mechanically install at corners 6" O.C. @ Lap #4 rows @ 6" inch O.C.
- 5. Install a layer of GAF Modified Smooth.
- 6. Install Final Layer of GAF Modified Granule
