December 2017	Miami Rescue Mission dba Broward Outreach Center (MRM/BOC) notified the Homeless Initiative Partnership (HIP) Administrator that due to budget shortfalls, MRM/BOC could not continue to fund the Overnight Bed Program (overnight beds and related support services for individual persons (males and females) experiencing homelessness) at the North (30 beds) and South (30 beds) Homeless Assistance Centers (HAC) past January 31, 2018.
January 2018	County Administrator sent letters to the City Managers of Pompano Beach and Hollywood (where the North and South HAC are located) advising of the potential loss of the Overnight Bed Program and requesting collaboration to develop a funding commitment with the County.
January - February 2018	Subsequently, HIP Administrator met with MRM/BOC and negotiated the continued provision of the Overnight Bed Program (60 overnight beds and related support services) through March 30, 2018, to allow the County to engage the cities of Pompano Beach and Hollywood to partner and share the costs of providing the overnight beds from April 1, 2018 through September 30, 2018 at the North and South HACs.
January - March 2018	HIP Administrator met with staff from the cities of Pompano Beach and Hollywood to provide background information about the North and South HACs, including the \$281,088 total cost of providing the Overnight Bed Program from April 1, 2018 through September 30, 2018 and reiterated the County's commitment to work collaboratively by matching each City's contribution.

April – June 2018

As a result of touring the North and South HAC facilities, the City of Pompano Beach committed \$70,272 (Exhibit 4) to fund the Overnight Bed Program (15 beds) at North HAC and the City of Hollywood committed \$40,000 (Exhibit 5) to fund the Overnight Bed Program (9 beds) at South HAC.

Due to a reorganization of agency funds, MRM/BOC is contributing \$67,681 to cover the remaining 12 South HAC overnight beds.

On May 30, 2018, the County received the executed agreement from the City of Pompano Beach.

On June 12, 2018, the County received the executed agreement from the City of Hollywood.
