RESOLUTION OF THE **BOARD** OF COUNTY COMMISSIONERS OF **BROWARD** COUNTY. FLORIDA, ORDERING THE BROWARD COUNTY VALUE ADJUSTMENT BOARD ("VAB") TO EXTEND THE ASSESSMENT PURSUANT TO SECTION 197.323, FLORIDA DIRECTING THE TRANSMISSION OF A CERTIFIED COPY OF THIS RESOLUTION TO THE VAB AND TO THE PROPERTY APPRAISER; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, due to the volume of petitions filed before the Broward County Value Adjustment Board ("VAB"), not all hearings of the VAB will be completed before November 1, 2018; and

WHEREAS, consistent with Section 3.06(A) of the Broward County Charter, all functions and duties of the Office of the Tax Collector were transferred to the Department of Finance and Administrative Services, and, more specifically, to the Director of the Records, Taxes and Treasury Division; and

WHEREAS, the Director of the Records, Taxes and Treasury Division of Broward County has requested that the VAB extend the assessment roll past November 1, 2018, through the completion of all VAB hearings, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:
