RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY. FLORIDA. ACCEPTING A DONATION OF A DOG PLAY GROUP ENRICHMENT SEMINAR AND TRAINING PROGRAM. VALUED AT THIRTEEN THOUSAND TWO HUNDRED **DOLLARS** (\$13,250), FROM **FRIENDS** BROWARD COUNTY ANIMAL CARE AND ADOPTION; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE ALL ADMINISTRATIVE AND BUDGETARY ACTIONS TO ACCEPTANCE; AND PROVIDING FOR **IMPLEMENT** SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, Friends of Broward County Animal Care and Adoption, a 501(c)(3) corporation located in West Palm Beach, Florida, has donated to the Animal Care and Adoption Division ("ACAD") a play group enrichment program called "Dogs Playing For Life," valued at Thirteen Thousand Two Hundred Fifty Dollars (\$13,250), providing for an onsite seminar and training of ACAD shelter staff for the purpose of bringing lifesaving play groups to animals at the ACAD shelter; and

WHEREAS, Section 18.63 of the Broward County Administrative Code provides for the acceptance and acknowledgment by the Board of County Commissioners of Broward County, Florida ("Board"), of donations to the County that are valued at Ten Thousand Dollars (\$10,000) or more; and
