2 A RESOLUTION OF THE BOARD OF COUNTY  
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,  
4 ACCEPTING A DONATION OF A DOG PLAY GROUP  
5 ENRICHMENT SEMINAR AND TRAINING PROGRAM,  
6 VALUED AT THIRTEEN THOUSAND TWO HUNDRED  
7 FIFTY DOLLARS (\$13,250), FROM FRIENDS OF  
8 BROWARD COUNTY ANIMAL CARE AND ADOPTION;  
9 AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE  
10 ALL ADMINISTRATIVE AND BUDGETARY ACTIONS TO  
11 IMPLEMENT ACCEPTANCE; AND PROVIDING FOR  
12 SEVERABILITY AND AN EFFECTIVE DATE.

13 WHEREAS, Friends of Broward County Animal Care and Adoption, a 501(c)(3)  
14 corporation located in West Palm Beach, Florida, has donated to the Animal Care and  
15 Adoption Division ("ACAD") a play group enrichment program called "Dogs Playing For  
16 Life," valued at Thirteen Thousand Two Hundred Fifty Dollars (\$13,250), providing for an  
17 onsite seminar and training of ACAD shelter staff for the purpose of bringing lifesaving  
18 play groups to animals at the ACAD shelter; and

19 WHEREAS, Section 18.63 of the Broward County Administrative Code provides  
20 for the acceptance and acknowledgment by the Board of County Commissioners of  
21 Broward County, Florida ("Board"), of donations to the County that are valued at  
22 Ten Thousand Dollars (\$10,000) or more; and

23 WHEREAS, the Board wishes to accept the generous gift and express its gratitude  
24 for the donation, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
BROWARD COUNTY, FLORIDA:

Section 1. The Board hereby accepts the donation from Friends of Broward  
County Animal Care and Adoption of the "Dogs Playing For Life" program, valued at

1 Thirteen Thousand Two Hundred Fifty Dollars (\$13,250), providing for an onsite seminar  
2 and training of ACAD shelter staff for the purpose of bringing lifesaving play groups to  
3 animals at the ACAD shelter.

4 Section 2. The County Administrator is hereby authorized to take all  
5 administrative and budgetary actions and execute all forms required to implement  
6 acceptance of the donation.

7 Section 3. SEVERABILITY.

8 If any portion of this Resolution is determined by any court to be invalid, the invalid  
9 portion will be stricken, and such striking will not affect the validity of the remainder of this  
10 Resolution. If any court determines that this Resolution, or any portion hereof, cannot be  
11 legally applied to any individual, group, entity, property, or circumstance, such  
12 determination will not affect the applicability hereof to any other individual, group, entity,  
13 property, or circumstance.

14 Section 4. EFFECTIVE DATE.

15 This Resolution is effective upon adoption.
