10 (b) Advocates are defined as individuals who are not providers and who do not
11 receive funding from Broward County. Advocates shall be free of any conflict of interest
12 incurred by being an employee of a nonprofit or for-profit agency receiving funding, and shall
13 submit a letter of resignation if a conflict develops after appointment.

14 ~~(b) (c)~~ Individuals from the community who are not appointed to the ~~Homeless~~
15 ~~Continuum of Care Board~~ HCOC may serve on task forces and subcommittees as established
