2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 DIRECTING THE OFFICE OF THE COUNTY
5 ADMINISTRATOR TO PUBLISH A NOTICE OF PUBLIC
6 HEARING TO BE HELD ON TUESDAY,
7 OCTOBER 23, 2018, AT 10:00 A.M., IN ROOM 422,
8 BROWARD COUNTY GOVERNMENTAL CENTER, FOR THE
9 PURPOSE OF RECEIVING PUBLIC INPUT ON THE
10 PROPOSED IMPLEMENTATION OF NEW LIMITED-STOP
11 FIXED-ROUTE BUS SERVICE ALONG BROWARD
12 BOULEVARD BETWEEN THE CITY OF SUNRISE AND
13 DOWNTOWN FORT LAUDERDALE TO BE KNOWN AS
14 "BROWARD BREEZE"; AND PROVIDING FOR AN
15 EFFECTIVE DATE.

16 WHEREAS, the Broward County Transportation Department is proposing the
17 implementation of new limited-stop fixed-route bus service along Broward Boulevard
18 between Sunrise and downtown Fort Lauderdale; and

19 WHEREAS, Broward County has received a grant from the Florida Department
20 of Transportation that will provide funding to assist with operations and maintenance
21 costs for the service; and

22 WHEREAS, pursuant to Federal Transit Authority and Broward County
23 regulations, a public hearing is required prior to implementing the new fixed-route bus
24 service, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
BROWARD COUNTY, FLORIDA:

Section 1. The County Administrator in and for Broward County, Florida, and
ex officio Clerk of the Board of County Commissioners of Broward County is authorized

1 and directed to publish notice of intent of the Board of County Commissioners of
2 Broward County to hold a public hearing on Tuesday, October 23, 2018,
3 at 10:00 a.m., for the purpose of receiving public input regarding the proposed
4 implementation of the Broward County Transportation Department's Broward Breeze
5 new limited-stop fixed-route bus service along Broward Boulevard between the City of
6 Sunrise and downtown Fort Lauderdale.

7 Section 2. Such notice shall be made no less than ten (10) days prior to the
8 date of the public hearing.

9 Section 3. Effective Date.

10 This Resolution will take effect upon adoption; provided, however, the Broward
11 Breeze limited-stop fixed-route bus service is expected to begin on January 1, 2019.
