

RESOLUTION NO. 2018-

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AUTHORIZING THE MAYOR TO EXECUTE A SUPPLEMENTAL JOINT PARTICIPATION AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION, DISTRICT 4, IN THE AMOUNT OF FIVE HUNDRED THOUSAND DOLLARS (\$500,000), TO PROVIDE ADDITIONAL FUNDING FOR THE BROWARD BREEZE LIMITED STOP BUS SERVICE FROM THE SAWGRASS MILLS MALL PARK AND RIDE IN SUNRISE TO DOWNTOWN FORT LAUDERDALE; AUTHORIZING THE COUNTY ADMINISTRATOR TO TAKE NECESSARY ADMINISTRATIVE AND BUDGETARY ACTIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 341, Florida Statutes, the Florida Department of Transportation ("FDOT") provides funding for intercity bus service programs; and

WHEREAS, Broward County is a recipient of such funds; and

WHEREAS, on June 1, 2018, Broward County and FDOT entered into a Joint Participation Agreement to provide funding for the Broward Breeze limited stop bus service along Broward Boulevard from the Sawgrass Mills Mall Park and Ride in Sunrise to Downtown Fort Lauderdale in the amount of Five Hundred Thousand Dollars (\$500,000) for Fiscal Year (FY) 2017-18; and

WHEREAS, FDOT has authorized Five Hundred Thousand Dollars (\$500,000) in additional funding for FY 2018-19 to supplement the Five Hundred Thousand Dollars (\$500,000) previously granted under Project Number 440262-1-84-01 for a total of One Million Dollars (\$1,000,000) in funding for the Broward Breeze limited stop bus service along Broward Boulevard from the Sawgrass Mills Mall Park and Ride in Sunrise to Downtown Fort Lauderdale; and

WHEREAS, the Supplemental Joint Participation Agreement ("SJPA") must be approved by the Board of County Commissioners of Broward County, Florida, NOW, THEREFORE,

1	BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD
2	COUNTY, FLORIDA:

4	Section 1. The Board of County Commissioners of Broward County, Florida
5	("Board"), hereby approves and authorizes the Mayor to execute an SJPA with FDOT, District 4,
6	in substantially the form attached as Exhibit 1, for FDOT to provide Five Hundred Thousand
7	Dollars (\$500,000) in additional funding for the Broward Boulevard Breeze limited stop bus
8	service from the Sawgrass Mills Mall Park and Ride to Broward Central Terminal for a total of
9	One Million Dollars (\$1,000,000) granted under Financial Project No. 440262-1-84-01.
10	Section 2. The Board authorizes the County Administrator to take all necessary
11	administrative and budgetary actions to implement the SJPA, including signing any necessary
12	time extensions.
13	Section 3. <u>Effective Date</u> .
