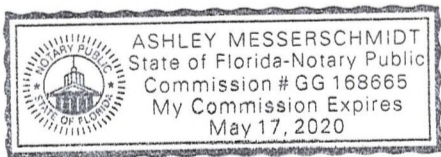

**NOTICE OF PUBLIC HEARING**  
NOTICE IS HEREBY GIVEN that a public hearing will be held by the Broward County Board of County Commissioners (the "Commissioners"), at its regularly scheduled meeting on September 13, 2018 at 10:00 a.m., or as soon thereafter as the same may be heard, at 115 South Andrews Avenue, Room 422, Fort Lauderdale, Florida 33301, for the purposes of receiving comments and hearing discussion concerning the issuance from time to time in one or more tax-exempt and taxable series pursuant to a plan of financing by the Capital Trust Agency (the "CTA") of its Educational Facilities Revenue Bonds (Championship Academy of Distinction of West Broward Project), in an amount not to exceed \$12,000,000 (the "Bonds"), the proceeds of which shall be loaned by the CTA to Championship Academy of Distinction K-8 (3) Inc., d/b/a Championship Academy of Distinction of West Broward, a Florida nonprofit corporation, and/or one or more related and/or affiliated entities (collectively, the "Borrower") and applied by the Borrower to (a) acquire, equip and improve a charter school facility known as Championship Academy of Distinction of West Broward (the "Facility"), which is located at 7100 West Oakland Boulevard, Sunrise, Broward County, Florida 33313 within the territorial limits of Broward County, Florida, and acquire and install related facilities, fixtures, furnishings and equipment; (b) refinance certain existing debt of the Borrower, if deemed necessary or desirable; (c) fund a debt service reserve fund for the Bonds, if deemed necessary or desirable; (d) fund any necessary capitalized interest; and (e) pay certain costs of issuing the Bonds (the purposes described in clauses (a) through (e) are hereinafter collectively referred to as the "Project").

The Bonds are expected to be issued pursuant to the Act (as hereinafter defined), by the CTA, a legal entity and public agency of the State of Florida, organized under and pursuant to the provisions of Chapter 163, Part I, Chapter 166, Part II, and Chapter 617, Florida Statutes; Ordinance No. 5-97 duly enacted by the City Council of the City of Gulf Breeze, Florida (the "City"), on July 7, 1997, as amended, restated and supplemented; Ordinance No. 2-00 duly enacted by the Town Council of the Town of Century, Florida (the "Town"), on August 7, 2000, as amended and supplemented; an Interlocal Agreement dated as of August 2, 1999, between the City and the Town, as amended and supplemented, and with powers as a "local agency" under Chapter 159, Part II, Florida Statutes, and other applicable provisions of law (collectively, the "Act").

The Bonds will be special limited obligations of the CTA payable solely from the trust estate which includes loan repayments to be made by the Borrower to the CTA, and certain moneys and securities on deposit in the funds and accounts held by the Trustee under the terms of the Trust Indenture for the Bonds. The Facility will be owned by the Borrower. The initial manager of the Facility will be Charter School Management Solutions LLC, or an affiliate thereof or another entity chosen by the Borrower.

The Bonds will not be a debt or liability of Broward County, the State of Florida or any political subdivision thereof, and neither Broward County, the State of Florida or any political subdivision thereof shall have any payment responsibility whatsoever in connection with the Bonds. The Bonds shall be special limited obligations of the CTA, payable solely from the trust estate.

A public hearing will be held pursuant to the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), at the above referenced time and place in connection with the proposed issuance of the Bonds to finance the costs of the Project described herein, at which time there will be an opportunity for persons to express their views on the foregoing. All interested taxpayers, property owners and citizens of Broward County are invited to attend this public hearing and, either personally or through their representative, will be given an opportunity to express their views concerning the Project to be financed with the proceeds of the Bonds. Written comments may be submitted on or before 4:00 p.m. September 12, 2018 to Broward County, 115 South Andrews Avenue, Suite 513, Fort Lauderdale, Florida 33301, Attention: Chief Financial Officer/Director, Finance and Administrative Services Department. If any auxiliary aids to communication are required, call the Office of Public Communications at 954-357-6990 so that arrangements can be made in advance. Comments made at the hearing and for the consideration of the Commissioners and will not bind the Commissioners as to any action they may take.

SHOULD ANY PERSON DECIDE TO APPEAL ANY DECISION MADE BY THE COMMISSIONERS AT THIS HEARING, HE OR SHE WILL NEED A RECORD OF THE PROCEEDINGS AND HE OR SHE MAY NEED TO ENSURE THAT A VERBATIM RECORD OF THE PROCEEDINGS IS MADE, WHICH INCLUDES THE TESTIMONY AND EVIDENCE UPON WHICH THE APPEAL IS TO BE BASED.
