3 A RESOLUTION OF THE BOARD OF COUNTY  
4 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,  
5 AUTHORIZING THE MAYOR TO EXECUTE A JOINT  
6 PARTICIPATION AGREEMENT WITH THE FLORIDA  
7 DEPARTMENT OF TRANSPORTATION, DISTRICT 4, IN  
8 THE AMOUNT OF ONE HUNDRED EIGHTY-TWO  
9 THOUSAND EIGHTY-EIGHT DOLLARS (\$182,088), TO  
10 PROVIDE FUNDING FOR LEASES AND OTHER COSTS  
11 ASSOCIATED WITH PARK AND RIDES FOR THE I-95  
12 EXPRESS BUS SERVICE; AUTHORIZING THE COUNTY  
13 ADMINISTRATOR TO TAKE NECESSARY  
14 ADMINISTRATIVE AND BUDGETARY ACTIONS; AND  
15 PROVIDING FOR AN EFFECTIVE DATE.

16 WHEREAS, pursuant to Chapter 341, Florida Statutes, the Florida Department of  
17 Transportation ("FDOT") provides funding for bus service programs;

18 WHEREAS, Broward County is a recipient of such funds;

19 WHEREAS, FDOT has approved One Hundred Eighty-two Thousand  
20 Eighty-eight Dollars (\$182,088) in funding for leases, lot enhancements, signage,  
21 shelters, stops, and other costs associated with park and rides, for the I-95 Express bus  
22 service for Fiscal Year (FY) 2018-19; and

23 WHEREAS, the Joint Participation Agreement ("JPA") must be approved by the  
24 Board of County Commissioners of Broward County, Florida, NOW, THEREFORE,

26 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF  
27 BROWARD COUNTY, FLORIDA:

29 Section 1. The Board of County Commissioners of Broward County, Florida  
30 ("Board"), hereby approves and authorizes the Mayor to execute a JPA with FDOT,

1 District 4, in substantially the form attached as Exhibit 1, for FDOT to provide One  
2 Hundred Eighty-two Thousand Eighty-eight Dollars (\$182,088) in funding for leases, lot  
3 enhancements, signage, shelters, stops, and other costs associated with park and  
4 rides, for the I-95 Express bus service granted under Financial Project  
5 No. 442692-1-94-01.

6 Section 2. The Board authorizes the County Administrator to take all  
7 necessary administrative and budgetary actions to implement the JPA, including signing  
8 any necessary time extensions.

9 Section 3. Effective Date.

10 This Resolution is effective upon adoption.
