History Boys and Girls Clubs of Broward County

In 1993, the Board of County Commissioners (BOCC) entered into agreements with the Boys & Girls Clubs of Broward County, Inc. (BGC), to provide funding to operate three recreational facilities for youth. The County owns the Carver Ranches Facility and Reitman Facilities and BGC does not pay rent for these buildings. The Lauderhill Facility building is leased from the City of Lauderhill for \$1 per year per the agreement with BGC for 93 years.

Funding:

Annually, BGC submits budget requests for program services and capital projects to the County for Board approval. BGC Club program services are funded with revenues from the Broward County Pay Telephone Commissions Trust Fund (Section 18-111 through 18.121, Code of Ordinances). The Trust Fund consists of fees from the pay telephone calls made by inmates in detention facilities. According to the Pay Telephone Trust Fund ordinance, the Board identified the Boys & Girls Clubs, Broward Sheriff's Office (BSO) Youth Programs, Broward County Homeless Assistance Programs and BSO Victim/Witness Programs as the priorities for the Trust Fund. Due to a steady decline of Trust Fund revenue, the County has appropriated General Revenue Funds for the BGC program services. On December 14, 2010 (Item No. 39), the Board approved a budget transfer of \$184,775 from the General Fund Commission Reserve to the BGC. BGC capital expenses are funded through the General Fund. In Fiscal Year 2018, the County approved a Five-Year Capital Program (Fiscal Year 2019 through Fiscal Year 2022) for the three BGC Club Facilities.
