RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY. FLORIDA, AUTHORIZING APPROPRIATION AND DISBURSEMENT FLORIDA DEPARTMENT OF LAW ENFORCEMENT EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT FUNDS TO SERVICE PROVIDERS FOR FISCAL YEAR 2018-2019 IN THE AMOUNT OF \$612,489 AND BROWARD COUNTY FUNDS IN THE AMOUNT OF \$53,582 FOR A TOTAL AMOUNT OF \$666,071; AUTHORIZING THE ADMINISTRATOR COUNTY TO EXECUTE **AGREEMENTS** AND TO TAKE ALL NECESSARY BUDGETARY ADMINISTRATIVE AND ACTIONS IMPLEMENT THE AGREEMENTS; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Broward County, Florida ("Board"), desires to appropriate Florida Department of Law Enforcement ("FDLE") Edward Byrne Memorial Justice Assistance Grant ("JAG") funds to the service providers listed on Attachment A for the provision of youth support services for Fiscal Year 2018-2019;

WHEREAS, Broward County will contribute funds in the amount of Fifty-three
Thousand Five Hundred Eight-two Dollars (\$53,582) to supplement the Byrne JAG
contract administration costs that are not funded by the grant;

WHEREAS, the Board desires to authorize the Broward County Administrator ("County Administrator") to execute, on behalf of the Board, the individual agreements, addenda, and amendments with the specified providers; and

WHEREAS, the Board finds that these services benefit the residents of Broward County and serve a public purpose, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

## Section 1. Authorized Appropriations and Disbursements.

The Board hereby authorizes an appropriation and disbursement of FDLE JAG funds in the amount of Six Hundred Twelve Thousand Four Hundred Eighty-nine Dollars (\$612,489) to the service providers listed in Attachment A, and disbursement of Broward County matching funds in the amount of Fifty-three Thousand Five Hundred Eighty-two Dollars (\$53,582) for a total amount of Six Hundred Sixty-six Thousand Seventy-one Dollars (\$666,071) for Fiscal Year 2018-2019.

### Section 2. Execution of Agreements by the County Administrator.

The County Administrator is hereby authorized to execute agreements with the service providers listed in Attachment A in substantially the same form as the Board-approved form agreement, as applicable, to amend the agreements as authorized by the Board, and to take all necessary budgetary and administrative actions to implement the agreements beginning November 1, 2018. Nothing in this Resolution will be construed to alter the requirement that the agreements be approved by the Office of the County Attorney prior to execution. Any material deviations from the standard form agreement must be presented to the Board for approval.

#### Section 3. Severability.

If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in part, cannot be legally applied to any individual, group, entity, property, or circumstance, such determination will not affect the applicability of this Resolution to any other individual, group, entity, property, or circumstance.
