

RESOLUTION NO. 2018-

1 A RESOLUTION OF THE BOARD OF COUNTY
2 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
3 PERTAINING TO PARATRANSIT SERVICES; AMENDING
4 SECTION 41.04 OF THE BROWARD COUNTY
5 ADMINISTRATIVE CODE ("ADMINISTRATIVE CODE") TO
6 CLARIFY THE FARE FOR ADA PARATRANSIT TRIPS;
7 AND PROVIDING FOR SEVERABILITY, INCLUSION IN
8 THE ADMINISTRATIVE CODE, AND AN EFFECTIVE
9 DATE.

10 WHEREAS, 49 C.F.R. Section 37.121 requires each public entity operating a
11 fixed route transit system to provide paratransit or other special service to individuals
12 with disabilities that is comparable to the level of service provided to individuals without
13 disabilities who use the fixed route system;

14 WHEREAS, 49 C.F.R. Section 37.121 restricts the fare that operators can charge
15 for ADA paratransit trips;

16 WHEREAS, the Board desires to amend Section 41.04 of the Administrative
17 Code to clarify the fare for ADA paratransit trips consistent with federal regulations; and

18 WHEREAS, the Board finds that the revisions to the Administrative Code as set
19 forth herein are necessary and in the best interest of Broward County, NOW,
20 THEREFORE,

21 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
22 BROWARD COUNTY, FLORIDA:

23 Section 1. Section 41.04 of the Broward County Administrative Code is hereby
24 amended to read as follows:

1 **41.04. Paratransit Fare Structure.**

2 The Paratransit fare structure shall be as follows:

	<i>Fee</i>
3	
4 a. Designated nutrition site trips.....	\$0.00
5 b. ADA Paratransit trips <u>shall not exceed twice the fare that</u>	
6 <u>would be charged to an individual paying full fare on fixed</u>	
7 <u>route up to a maximum of</u>	\$3.50
8 c. Veterans Administration Clinic site trips within the Broward	
9 County service area for Paratransit eligible Veterans	\$1.75
10 d. Subsidized transportation card. County payment shall not	
11 exceed \$15.00 per trip.	
12 e. Annual Bus Pass for eligible Transportation Disadvantaged	
13 customers (TD Bus Passes)	\$0.00

14 Section 2. Severability.

15 If any portion of this Administrative Code Resolution is determined by any court
16 to be invalid, the invalid portion will be stricken, and such striking will not affect the
17 validity of the remainder of this Administrative Code Resolution. If any court determines
18 that this Administrative Code Resolution, in whole or in part, cannot be legally applied to
19 any individual, group, entity, property, or circumstance, such determination will not
20 affect the applicability of this Administrative Code Resolution to any other individual,
21 group, entity, property, or circumstance.

22 Section 3. Inclusion in the Broward County Administrative Code.

23 It is the intention of the Board of County Commissioners that the provisions of
24 this Administrative Code Resolution become part of the Broward County Administrative
