LOCALLY FUNDED AGREEMENT (LFA)  
AMENDMENT NUMBER ONE

THIS Amendment, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_\_, by and between the State of Florida Department of Transportation, an agency of the State of Florida, hereinafter called the DEPARTMENT, and the Broward County located at 1 North University Drive, Suite #300B, Plantation, Florida 33324, hereinafter called the COUNTY.

WITNESSETH

WHEREAS, on April 7<sup>th</sup>, 2017 the parties entered into a Local Funded Agreement (LFA), wherein the COUNTY agreed to provide certain improvements in connection with the drafting of a Request for Proposal (RFP) for the DEPARTMENT's milling and resurfacing of Riverland Road/SW 27<sup>th</sup> Avenue from SR7/US-441 to SR-842/Broward Blvd in Broward County, Florida, as well as the "projects", hereinafter set forth (Projects); and

WHEREAS the COUNTY's project refers to FM numbers 440746-5-31-01 and 440746-5-32-01 (hereinafter referred to as "Project"); and

WHEREAS, the parties hereto intended to draft the RFP for the milling and resurfacing of Riverland Road/SW 27<sup>th</sup> Avenue from SR7/US-441 to SR-842/Broward Blvd in Broward County, Florida and not the development (Design) of a full set of signed and sealed construction plans; and

WHEREAS, the parties desire to further amend the Agreement; and

WHEREAS, the parties hereto mutually agree that this Amendment is in their best interest;

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations herein, the parties agree to amend that certain Local Funded Agreement (LFA) dated April 7<sup>th</sup>, 2017, as follows:

1. The recitals set forth above are true and correct and are deemed incorporated herein.
2. This Amendment adds eight (8) Financial Management Numbers to this Agreement. The First WHEREAS paragraph of the Agreement is amended to read as follows:

WHEREAS, the parties hereto intended to draft a Request For Proposal (RFP) for the milling and resurfacing of Riverland Road/SW 27<sup>th</sup> Avenue from SR7/US-441 to SR-842/Broward Blvd in Broward County, Florida as set forth below, and not the development (Design) of a full set of signed and sealed construction plans.

1. Hammondville Road from Powerline Road to east of SR-9/I-95  
FM 440746-1-31-01 and 440746-1-32-01
2. NW 31<sup>st</sup> Avenue, from SR-870/Commercial Blvd to McNab Road

- FM 440746-2-31-01 and 440746-2-32-01
- 3. SR845/Powerline Road from SR816/Oakland Park Blvd to SR870/Commercial Blvd  
FM 440746-3-31-01 and 440746-3-32-01
- 4. Lauderdale Lakes Greenway, from NW 29<sup>th</sup> Avenue to NW 31<sup>st</sup> Avenue Intersection  
FM 440746-4-31-01 and 440746-4-32-01
- 5. Riverland Road /SW 27th Avenue, from SR-7/US441 to SR-842/Broward Blvd  
FM 440746-5-31-01 and 440746-5-32-01

3. Paragraph 5 of the Local Funded Agreement (LFA) is amended to read as follows:

The COUNTY is responsible for 100% of the cost of their Project. In the event the actual cost of their Project, without modifications, results in a sum greater than that paid by the COUNTY, then such sum shall be the sole responsibility of the COUNTY and shall be paid to the DEPARTMENT.

The COUNTY's cost for the FM Numbers set forth above in this paragraph is estimated at TWO HUNDRED TWO THOUSAND FIVE HUNDRED FIFTY NINE DOLLARS AND NO CENTS (\$202,559.00) which sum was received by the DEPARTMENT on June 28, 2017.

The payment made by the City of Pompano Beach in accordance with the terms of their Local Funded Agreement resulted in a fund balance amount of THREE HUNDRED EIGHTEEN THOUSAND THREE HUNDRED TWENTY-FOUR DOLLARS AND NINETY SIX CENTS (\$318,324.96) ("Fund Balances"). The DEPARTMENT and the COUNTY hereby agree that the Fund Balances shall be assigned to the following Financial Management Numbers:

In the event the Fund Balances are not utilized in its entirety, any unused Fund Balances will be refunded to the following Financial Project Numbers; 440746-1-31-01 and 440746-1-32-01.

4. The Scope of Services of the Agreement is deleted in its entirety and replaced with **Exhibit A** of this Amendment, attached hereto and made a part hereof.

All provisions, covenants, terms and conditions of the Agreement between the parties theretofore entered on April 7<sup>th</sup>, 2017, as originally set forth therein, which are not hereby expressly amended or modified and not in conflict with the terms hereof, are hereby ratified and confirmed and shall remain the same and be unaffected by these presents.

## EXHIBIT A SCOPE OF WORK

The Scope of Services for the following DEPARTMENT Projects are as follows:

- 1) Hammondville Road from Powerline Road to east of SR-9/I-95 in Broward County, Florida  
FM 440746-1-31-01 and 440746-1-32-01

The DEPARTMENT shall design a 4-lane divided roadway to be constructed along Hammondville Road from Powerline Road to east of SR-9/I-95. The Project shall include, but not be limited to the milling and resurfacing of Hammondville Road to restripe the pavement markings to reduce the lane widths and to accommodate buffered bike lanes in each direction. Existing sidewalks reconstructed/retrofitted to comply with ADA standards where needed.

- 2) NW 31<sup>st</sup> Avenue, from SR-870/Commercial Blvd to McNab Road  
FM 440746-2-31-01 and 440746-2-32-01

The DEPARTMENT shall design a 6-lane divided roadway along NW 31<sup>st</sup> Avenue from SR870/Commercial Blvd. to McNab Road. The Project shall include, but not be limited to the design for the milling and resurfacing of NW 31<sup>st</sup> Avenue, reducing the three through lanes widths from 12 feet to 11 feet and widening of 2 feet towards inside of the median on both side of the segment in order to accommodate continuous bicycle lanes. Signal improvements have been included at three intersections within the Project limits.

- 3) SR845/Powerline Road from SR816/Oakland Park Blvd to SR870/Commercial Blvd  
FM 440746-3-31-01 and 440746-3-32-01

The DEPARTMENT shall design a 4-lane divided roadway to be constructed along SR845/Powerline Road from SR-817/Oakland Park Blvd. to SR-870/Commercial Blvd. The Project shall include, but not be limited to the elimination of outside through lane and convert it to a buffered bike lane and providing landscaped islands within the project limits.

- 4) Lauderdale Lakes Greenway, from NW 29<sup>th</sup> Avenue to NW 31<sup>st</sup> Avenue Intersection  
FM 440746-4-31-01 and 440746-4-32-01

The DEPARTMENT shall design a multi-purpose path to be constructed within the limits of NW 29<sup>th</sup> Avenue to NW 31<sup>st</sup> Avenue Intersection. The enhancements will extend the Lauderdale Lakes Greenway from NW 29<sup>th</sup> Avenue to NW 31<sup>st</sup> Avenue intersection shall include pedestrian lighting, landscaping, and various aesthetic features.

- 5) Riverland Road /SW 27<sup>th</sup> Avenue, from SR-7/US441 to SR-842/Broward Blvd  
FM 440746-5-31-01 and 440746-5-32-01

The DEPARTMENT shall design a 2 lane roadway and 3-lane roadway along Riverland Road/SW 27<sup>th</sup> Avenue from SR-7/US-441 to SR-842/Broward Blvd (SR-7/US-441 to SW 13<sup>th</sup> Court is a two lane roadway. Davie Blvd. to Broward Blvd is a four lane roadway). The Project shall include, but not be limited to the milling and resurfacing of Riverland Road, reducing through lane widths from 12ft. to 11ft. and widening by 4ft to provide bicycle lanes in both directions of Riverland Road from SR-7 to Davie Blvd; also milling and resurfacing of SW 27<sup>th</sup> Avenue for restriping existing lane configuration to remove a single travel lane in each direction to provide bicycle lanes from Davie Blvd. to Broward Blvd. Internally illuminated reflective pavement markings will be installed throughout the entire project and the strain pole at SW 34<sup>th</sup> Way will be replaced with a mast arm.
