Project scope includes the update of the Broward County 100-year Flood Elevation Map with incorporation of future climatic

conditions, including sea level rise, through the refinement and application of the latest Broward County-wide Integrated MIKE Model

Project deliverables include the Future Conditions 100-Year Flood Elevation Map and Associating Modeling, utility tools, CRS Evaluation and Recommendation Reports and Final Summary Report.
