Compliance Comments

Carollo Engineers, Inc.(Carollo) has committed to 20.8% and has attained 19% CBE participation to date. In January 2018, Carollo added Gamboa Engineers, LLC as a CBE subconsultant to provide Electrical Engineering Services for 2.4%. Carollo had originally assigned this scope to Chen Moore and Associates (Chen Moore). Per the proposed Fourth (4th) Amendment, Carollo has reassigned the Electrical Engineering scope to Gamboa but increased Chen Moore's overall contract amount. In terms of the overall contract, Carollo's CBE commitment remains at 20.8%. OESBD will continue to monitor Carollo Engineers Inc.'s compliance with the established overall goal.
