The Florida Department of Transportation and Broward County desires to supplement the original Agreement entered into and executed on February 9, 2017 as identified above. All provisions in the original Agreement and supplements, if any, remain in effect except as expressly modified by this supplement.

The changes to the Agreement and supplements, if any, are described as follows:

PROJECT DESCRIPTION

Name Davie Road Extension Length 1.462 miles

Termini SR-817/University Drive to SR-848/Stirling Road

Description of Work:

On Davie Road from SR-817/University Drive to SR-848/Stirling Road, the construction of 5 foot bicycle lanes with 3 foot buffer on both sides of the road, the addition of missing 6 feet wide sidewalks on both sides of the road, the regrading of swales, the relocation of approximately 16 existing bus stops and the addition of an ADA compliant bus pad at an existing bus stop as well as updating signing and pavement markings.

Reason for Supplement and supporting engineering and/or cost analysis:

This Supplemental Agreement amends the first sentence of paragraph 3. "Term of Agreement" of the Original Agreement to read as follows:

The Agency agrees to complete the Project on or before June 30, 2019.
