- Unsatisfactory delivery time and failure to deliver information.
- Failure to report landscaping issues in a timeline manner.

The vendor performance issues appeared to have been isolated to specific projects. The vendor has taking corrective actions and assured HBMD performance issues will not occur in the future.

In addition, HBMD obtained positive references from entities and other County agencies that had contracts with the vendor in the past three years (refer to attachments).
