ORDINANCE NO. 2018-

1 AN ORDINANCE OF THE BOARD OF COUNTY
2 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
3 PERTAINING TO THE MEDICAL MARIJUANA ADVISORY
4 BOARD ("MMAB"); AMENDING SECTION 1-311 OF THE
5 BROWARD COUNTY CODE OF ORDINANCES ("CODE");
6 PROVIDING QUORUM REQUIREMENTS FOR THE MMAB;
7 AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE
8 CODE, AND AN EFFECTIVE DATE.

11 BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF
12 BROWARD COUNTY, FLORIDA:

13 Section 1. Section 1-311 of the Broward County Code of Ordinances is hereby
14 amended to read as follows:

15 **Sec. 1-311. Meetings; organization; and quorum.**

16 . . .
17 (d) A majority of the ~~total~~ appointed members of the MMAB shall constitute a
18 quorum. A simple majority of votes by the members present and constituting a quorum
19 shall be necessary in order to adopt any measure.

20 Section 2. Severability.

21 If any portion of this Ordinance is determined by any court to be invalid, the invalid
22 portion will be stricken, and such striking will not affect the validity of the remainder of
23 this Ordinance. If any court determines that this Ordinance, in whole or in part, cannot
24 be legally applied to any individual, group, entity, property, or circumstance, such
determination will not affect the applicability of this Ordinance to any other individual,
group, entity, property, or circumstance.

1 Section 3. Inclusion in the Broward County Code of Ordinances.

2 It is the intention of the Board of County Commissioners that the provisions of
3 this Ordinance become part of the Broward County Code of Ordinances as of the
4 effective date. The sections of this Ordinance may be renumbered or relettered and the
5 word "ordinance" may be changed to "section," "article," or such other appropriate word
6 or phrase to the extent necessary in order to accomplish such intention.

7 Section 4. Effective Date.

8 This Ordinance is effective as of the date provided by law.
