Parking Garage updates as of 12/07/2018

Accreditation of Child Care Centers and Early Learning Facilities:

- ECPD Gold Seal Team formed and coordination meetings ongoing; enabling ordinance and code changes drafted and anticipated to be before the Commission in January 2019; flagship outreach brochure drafted and under review by all Gold Seal Partners; coordination with Office of Public Communication ongoing for marketing campaign; formal kick-off planned for April (month of the child) 2019.

MSD Investigative Report:

- The Police Foundation continues to review documentation related to the February 14, 2018 incident at Marjory Stoneman Douglas High School. A draft report is expected in mid-December 2018, and all other aspects of the review to include a gap analysis will be conducted by the Police Foundation once other investigation reports have been completed by other agencies.

Lauderhill Transit Center-Construction Update:

- Pending successful approvals of redesign, permitting and bidding, construction should start September 2019 and end September 2020.

Bridge Scholarship Program-Implementation Information:

- The County has established an internal team to work on this initiative and will be expanded to include other areas of County specialties as it continues to unfold. Currently, the team consists of: the Deputy County Administrator, the Director of the Office of Economic and Small Business Development, and the Director of the Libraries Division. Discussions have been initiated with Broward College and County staff is currently conducting demographic research.

Convention Center Hotel:

- We are currently in schematic design for the project including relocation of the central energy plant and reconfiguration of the Northport parking garage. Additionally, the final development contract is being negotiated and is expected to be brought back to the Board Q3 FY 2019.

P-25 System for Emergency Systems:

- Progress continues on the implementation of the P25 Public Safety Radio Project. The next major milestone is to secure the second tower site location in the city of Hollywood. The city is scheduled to review this item at their [December 19, 2018](#) Board meeting.

Mayor Skip Campbell and TJ Reddick Courthouse Wing:

- The County Attorney's Office has been working with administrative staff from the offices of Mayor Mark Bogen and Vice-Mayor Dale Holness on the proposals for naming portions of the courthouse after the late Mayor Skip Campbell and the Honorable TJ Reddick. To assure that the agenda item is compliant with Section 18.43 of the Broward County Administrative Code ("Code"), administrative staff is obtaining letters in support of the proposals to accompany the agenda item. Additionally, under the Code, the soonest that the item may be considered is at least ninety (90) days after the death of the person to be honored. Our goal is to proceed simultaneously with both proposals at the January 29, 2019 commission meeting following the minimum 90 day waiting period and staff's completion of obtaining supporting letters required under the Code. This timeline is based on the proposed meeting schedule for calendar year 2019 slated for the Board's consideration at the December 11, 2018 commission meeting.

Secondhand Media Dealers Ordinance:

- The proposed Secondhand Dealer Ordinance is undergoing final review by this office. We anticipate that the ordinance will be forwarded to Commissioner Sharief in the next few days for her review and approval. This item is expected to be set for public hearing by February 2019.

Solid Waste—Consultants Final Report and Next Steps:

- Arcadis, the consultant for the Solid Waste and Recycling Issues Study, presented the Interim Final Report to the Broward League of Cities on November 29, 2018. A Memorandum of Understanding will be circulated to Broward County's 31 municipalities to gauge their interest in participating as a member of a future solid waste disposal district.

Living Wage Ordinance:

- An agenda item is on the December 11, 2018 Commission Meeting for consideration. Staff is awaiting direction from the Board.

Text to 911 System

- Progress continues to be made on the implementation of Text to 911 during the month of December 2018 with full roll-out occurring this fiscal year. PSAP training and carrier activation testing is underway. In addition, County staff is in the progress of developing a communication strategy as part of the community outreach on the use of Text to 911.

Spectrum Building Analysis and Spec Sheet:

- A letter to Mr. Sheldon Gross regarding the Spectrum building was sent on December 7, 2018 requesting a meeting for December 12, 2018. Board members were copied on this letter. As indicated in the letter, it was requested that a final proposal be submitted to the County from Mr. Gross for review with an anticipated discussion with Board on January 29, 2019.
