RESOLUTION OF THE **BOARD** OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA. DIRECTING THE COUNTY ADMINISTRATOR TO PUBLISH A NOTICE OF PUBLIC HEARING TO BE HELD ON TUESDAY. JANUARY 29, 2019, ΑT 10:00 A.M.. 422 BROWARD COUNTY GOVERNMENTAL CENTER, FOR THE PURPOSE OF RECEIVING PUBLIC INPUT ON THE PROPOSED ELIMINATION OF BROWARD COUNTY TRANSIT DIVISION'S 95 EXPRESS **PEMBROKE** ROUTE 107 BETWEEN **PINES CENTER** HOLLYWOOD THE MIAMI CIVIC TO DOWNTOWN MIAMI, DUE TO RIDERSHIP LEVELS BELOW PERFORMANCE STANDARDS AGREED-UPON BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FUNDING PARTNER) AND BROWARD COUNTY; AND PROVIDING FOR AN ÉFFECTIVE DATE.

WHEREAS, Broward County and the Florida Department of Transportation have entered into annual Joint Participation Agreements with the Florida Department of Transportation since 2010 to provide funding for operations and maintenance of Interstate 95 Express Bus service and have established agreed-upon performance standards for ridership levels;

WHEREAS, ridership has decreased below agreed-upon performance levels on the 95 Express Route 107 between the western Broward cities of Pembroke Pines and Hollywood to the Miami Civic Center in downtown Miami due to the availability of a nearby 95 Express Route (Route 108) with faster travel times;

WHEREAS, the Florida Department of Transportation requested that the route be discontinued due to low ridership and will be eliminating funding for the route; and

1 WHEREAS, the County is required to provide an opportunity for public input prior 2 to eliminating a bus route, NOW, THEREFORE, 3 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF 4 BROWARD COUNTY, FLORIDA: 5 6 7 Section 1.
