8 directed to publish notice of intent of the Board of County Commissioners of Broward
9 County to consider at public hearing on Tuesday, January 29, 2019, at 10:00 a.m., the
10 adoption of a Resolution Amending the Broward County Administrative Code, to be

17 ("ADMINISTRATIVE CODE"), PROVIDING FOR CHANGES
18 TO ORGANIZATION AND FEES; RELOCATING THE CHILD
19 CARE LICENSING AND ENFORCEMENT SECTION FROM
20 THE COMMUNITY PARTNERSHIPS DIVISION, HUMAN
21 SERVICES DEPARTMENT, TO THE ENVIRONMENTAL
22 AND CONSUMER PROTECTION DIVISION,
23 ENVIRONMENTAL PROTECTION AND GROWTH
24 MANAGEMENT DEPARTMENT; REPEALING PART II OF
CHAPTER 36 OF THE ADMINISTRATIVE CODE;
CREATING SECTION 40.51 RELATING TO CHILD CARE
FACILITY AND FAMILY CHILD CARE HOME LICENSE AND
REGISTRATION FEES; AND PROVIDING FOR
SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE
CODE, AND AN EFFECTIVE DATE."

23 Section 2. Such notice shall be made pursuant to the applicable provisions of
24 Section 3.04 of the Broward County Charter.
