CBE Compliance Evaluation: Amendment #3 – Saltz Michelson Architects, Inc.

The Office of Economic and Small Business Development (OESBD) has conducted a review of Saltz Michelson Architects, Inc's CBE participation as of October 31, 2018. The CBE goal for the agreement is 20% and is applicable to basic services. Saltz Michelson Architects, Inc. committed to a 20% CBE commitment. An overview is provided as follows:

Compliance Comments

Saltz Michelson Architects, Inc. has achieved 17% CBE participation as of October 31, 2018, which reflects a 3.0% deficit of the 20% commitment.

Saltz Michelson Architects, Inc. submitted a Plan of Action on December 17, 2018 describing the firm's intent to cure the deficit and attain the 20% commitment. The Plan of Action proposes that CBE subconsultants will begin work on Saltz Michelson Architects, Inc. amended contract in April or May 2019. MURs submitted after this time frame shall reflect Saltz Michelson Architects, Inc's intent to cure the 3.0% deficit.

Payments stated in this review were verified through the independent verification process.

The commitment for this project remains at 20%, and OESBD will continue to monitor this project for CBE compliance.
