ELEVENTH AMENDMENT TO AGREEMENT BETWEEN BROWARD COUNTY AND SHERIFF OF BROWARD COUNTY FOR LAW ENFORCEMENT SERVICES AT THE FORT LAUDERDALE-HOLLYWOOD INTERNATIONAL AIRPORT

This Eleventh Amendment ("Eleventh Amendment") to the Agreement for Law Enforcement Services at the Fort Lauderdale-Hollywood International Airport is entered into between Broward County, a political subdivision of the State of Florida ("County") and Scott Israel, as the Sheriff of Broward County, Florida ("Sheriff") (collectively referred to as the "Parties").

RECITALS

- A. County owns and operates the Fort Lauderdale-Hollywood International Airport ("Airport").
- B. The Sheriff performs contracted law enforcement services for the Airport pursuant to an agreement between the Parties dated November 12, 1996, which agreement, sometimes referred to as the Airport LEO Agreement, has been previously amended ten times (such agreement as amended is hereinafter referred to as the "Airport LEO Agreement").
- C. The Parties are desirous of adjusting the staffing level to add one Lieutenant, one Sergeant, and one Administrative Specialist I.
- D. The Airport LEO Agreement requires that changes in staffing be made by an amendment to reflect the new staffing.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties amend the Airport LEO Agreement as follows:

- 1. The above Recitals are true and correct and incorporated herein by reference.
- 2. This Eleventh Amendment shall be effective as of the date it is fully executed by the Parties.
- 3. **Exhibit A**, Account Detail/Justification, to the Airport LEO Agreement is hereby deleted in its entirety and replaced with **Exhibit A** attached hereto. As of the Effective Date of this Eleventh Amendment, all references to **Exhibit A** in the Airport LEO Agreement shall refer to the **Exhibit A** attached to this Eleventh Amendment.
- 4. **Revised Exhibit B**, Staffing Levels, to the Airport LEO Agreement is hereby deleted in its entirety and replaced with an updated **Revised Exhibit B** attached hereto. As of the Effective Date of this Eleventh Amendment, all references to **Revised Exhibit B** in the Airport LEO Agreement shall refer to the updated **Revised Exhibit B** attached to this Eleventh Amendment. The annual compensation paid to Sheriff will be adjusted accordingly to account for the additional staffing positions.

- 5. This Eleventh Amendment incorporates and includes all prior negotiations, correspondence, agreements, discussions, and understandings applicable to the matters contained herein. The Parties agree that there are no commitments, agreements, or understandings concerning the subject matter of this Eleventh Amendment that are not contained in this Eleventh Amendment.
- 6. Preparation of this Eleventh Amendment has been a joint effort of the Parties and the resulting document shall not, solely as a matter of judicial construction, be construed more severely against one of the Parties than the other.
- 7. Except as modified in this Eleventh Amendment, all terms and conditions of the Airport LEO Agreement shall remain in full force and effect. If any conflict or ambiguity exists between this Eleventh Amendment and the Airport LEO Agreement, the Parties agree that this Eleventh Amendment shall control.
- 8. This Eleventh Amendment may be executed in multiple originals and may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same agreement.
- 9. In the event the Airport LEO Agreement, as amended, or a portion of the Airport LEO Agreement, as amended, is found by a court of competent jurisdiction to be invalid, the remaining provisions shall continue to be effective unless either party elects to terminate the Airport LEO Agreement. The election to terminate the Airport LEO Agreement based upon this provision shall be made within seven (7) days after the finding by the court becomes final.
