Fiscal Year 2018 Tree Preservation Trust Fund Annual Report

INTRODUCTION

Section 27-413 of the Broward County Code of Ordinances states, "The Broward County Tree Preservation Trust Fund has been created in the general trust fund of Broward County for the purpose of accepting and disbursing the contributions made to the Board as part of tree removal licenses...". Section 27.188d of the Broward County Administrative Code states, "The Accounting Division, with the assistance of EPGMD, shall prepare and submit an Annual Report to the Board for the projects funded and disbursements made from the Tree Preservation Trust Fund." This memorandum (with attachment) constitutes the Tree Preservation Trust Fund Annual Report for Fiscal Year 2018.

BACKGROUND

The Tree Preservation Trust Fund was established in September, 1983. Administration of the fund is the responsibility of the Environmental Protection and Growth Management Department (EPGMD) under the guidance of a staff committee composed of representatives from the Public Works Department, the Parks and Recreation Division, and EPGMD. The Committee reviews requests for funding and initiates projects dealing with rights of way, parks and other sites that enhance the tree canopy of the County. Once the projects are approved, EPGMD coordinates the installation and monitoring of the projects to ensure long term viability.

DISBURSEMENTS FOR FISCAL YEAR 2018

Disbursements for Fiscal Year 2018 totaled \$89,398. Below is a list of projects that have been approved for expenditure.

SUMMARY

Attached is the Fiscal Year 2018 financial statement for the fund, prepared by the Accounting Division. Total revenue for the referenced time period was \$44,465. Total funds disbursed during the referenced time period was \$89,398. The total fund balance as of September 30, 2018, was \$608,208. Projects ongoing and in the conceptual design phase are estimated to total \$153,416, leaving a reserve for future projects in the amount of \$454,792.
