2 A RESOLUTION OF THE BOARD OF COUNTY
3 COMMISSIONERS OF BROWARD COUNTY, FLORIDA,
4 NAMING THE SEVENTEENTH JUDICIAL CIRCUIT COURT
5 OF FLORIDA JUDICIAL COMPLEX WEST WING LOCATED
6 AT 201 SE 6TH STREET, FORT LAUDERDALE, FLORIDA
7 33301 AS THE "WALTER G. 'SKIP' CAMPBELL JR. WEST
8 WING" IN MEMORY OF SKIP CAMPBELL; AUTHORIZING
9 THE COUNTY ADMINISTRATOR TO TAKE ALL
10 NECESSARY ACTION TO IMPLEMENT SAME; AND
11 PROVIDING FOR SEVERABILITY AND AN EFFECTIVE
12 DATE.

14 WHEREAS, "Skip" Campbell was born on November 12, 1948, in Rockaway
15 Beach, New York;

16 WHEREAS, Skip Campbell graduated from the University of Florida in 1970 and
17 from the University of Florida College of Law in 1973;

18 WHEREAS, Skip Campbell was co-founder of the law firm Krupnick & Campbell,
19 formed in 1975;

20 WHEREAS, Skip Campbell served as State Senator from 1996 until he was term-
21 limited in 2006;

22 WHEREAS, Skip Campbell, a resident of Coral Springs for thirty-six (36) years,
23 was elected Mayor of Coral Springs in 2014, reelected in 2016, and reelected again in
24 2018;

WHEREAS, Skip Campbell was also a leader in Bar-related matters including
serving, at various points in his career, as President of the Broward County Bar
Association, President of the Broward County Young Lawyers Association, President of

1 the Federal Bar Association of Broward County, and as a member of The Florida Bar
2 Board of Governors;

3 WHEREAS, Skip Campbell's passion in helping others led to him receiving many
4 awards, honors, and recognitions including being named Child Advocate of the Year and
5 receiving the Leadership Award from the Police Academy;

6 WHEREAS, Skip Campbell was a renowned lawyer respected by his peers and
7 the many judges before whom he appeared;

8 WHEREAS, Skip Campbell lived a life dedicated to public service, and his political
9 leadership and career were seen as an extension of his staunch beliefs in representing
10 the interests of his community and the pursuit of justice for all; and

11 WHEREAS, Skip Campbell was known and will be remembered as a consummate
12 statesman and defender of civil liberties, whose colleagues and constituents alike
13 expressed their honor and privilege to stand with him in public service and to call him
14 friend, NOW, THEREFORE,

16 BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF
17 BROWARD COUNTY, FLORIDA:

19 Section 1. That the Board of County Commissioners hereby names the
20 Seventeenth Judicial Circuit Court of Florida Judicial Complex West Wing, located at 201
21 SE 6th Street, Fort Lauderdale, Florida 33301, as the "Walter G. 'Skip' Campbell Jr. West
22 Wing" in honor and memory of the late former State Senator, Mayor, and prominent
23 attorney, Skip Campbell, for his many years of dedicated service to our community.

1 Section 2. That the County Administrator is authorized to take all administrative
2 actions necessary to implement this Resolution.

3 Section 3. Severability.

4 If any portion of this Resolution is determined by any court to be invalid, the invalid
5 portion will be stricken, and such striking will not affect the validity of the remainder of this
6 Resolution. If any court determines that this Resolution, in whole or in part, cannot be
7 legally applied to any individual, group, entity, property, or circumstance, such
8 determination will not affect the applicability of this Resolution to any other individual,
9 group, entity, property, or circumstance.

10 Section 4. Effective Date.

11 This Resolution is effective upon adoption.
