DISPOSAL AUTHORIZING THE OF COUNTY-OWNED REAL PROPERTY FROM AIRPORT SYSTEM PURSUANT TO SECTION 712 RESOLUTION NO. 2012-320, PERTAINING TO AIRPORT **MAKING** SYSTEM REVENUE BONDS DETERMINATION THAT THE DISPOSAL PROPERTY, WHICH CONSTITUTES A PART OF AIRPORT SYSTEM. WILL NOT IMPAIR THE OPERATING EFFICIENCY OF THE AIRPORT SYSTEM OR REDUCE CAPABILITY REVENUE-PRODUCING AIRPORT SYSTEM: AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

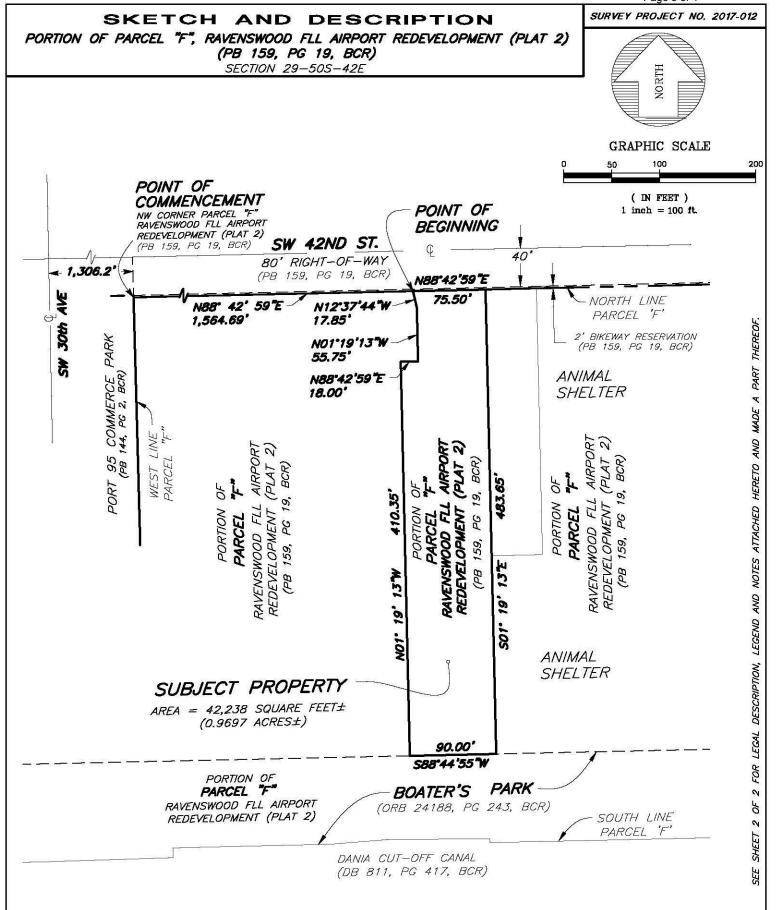

WHEREAS, Section 712 of Resolution No. 2012-320, pertaining to Airport System Revenue Bonds, requires that prior to the sale or disposal of property within the Airport System, the Board of County Commissioners of Broward County, Florida (the "Board"), by resolution, shall determine whether the sale or disposal of such property would impair the operating efficiency of the Airport System or reduce the revenue-producing capability of the Airport System; and

WHEREAS, the County presently owns the real property and such improvements as may be located thereon ("Property"), as more particularly described in Exhibit A, attached hereto and made a part hereof, which Property is presently part of the Airport System, NOW, THEREFORE,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

1 The Recitals set forth above are true and correct and incorporated Section 1. 2 by reference herein. 3 Based on the recommendation of the Director of the Aviation Section 2. 4 Department, the Board determines that the disposal of the Property from the Airport 5 System will not impair the operating efficiency of the Airport System or reduce the 6 revenue-producing capability of the Airport System. 7 Section 3. Severability. 8 If any portion of this Resolution is determined by any court to be invalid, the invalid portion will be stricken, and such striking will not affect the validity of the remainder of this Resolution. If any court determines that this Resolution, in whole or in 10 part, cannot be legally applied to any individual, group, entity, property, or circumstance, 11 12 such determination will not affect the applicability of this Resolution to any other 13 individual, group, entity, property, or circumstance. 14 Section 4.
